On the above date, I was on patrol when I observed a fight break out inside the bar. One employee was attempting to break up the fight when officers arrived inside. Both offenders where involved in mutual combat. I grabbed offender #1 and pulled him from the fight(they where on the floor just inside the front door), yelling at him that I was the police and for him to stop fighting. The offender, who was on his back, looked at me, drew back his right fist to take a swing at me. Before the offender could connect the punch, I rolled him onto his stomach, giving him commands to place his hands behind his back. The offender was arrested without further incident. The offender told me that he was only 20 years old (verified by GA license). He had a strong odor of an alcoholic beverage coming from his breath, glassy eyes, and was unsteady on his feet. The offender was transported to jail.
