## NARRATIVE

On 9/27/13, I was Eastbound on Lexington Road near the Marathon Gas Station when I observed a vehicle (D234GX-Florida) change lanes from the left lane to the right lane, and in the process, this vehicle nearly struck a vehicle that had established its position within the right lane.

I made a traffic stop and identified the driver as Carlton Thomas.

I-Leads showed that Thomas had a warrant out of Clarke County Municipal Court for Contempt of Court.

After the warrant was confirmed, I placed Thomas under arrest.

His vehicle was released to a licensed passenger [REDACTED] at his request.

Thomas was transported to CCSO, where he was booked in on the warrant only. He was given a citation for failure to maintain lane, but he was not booked in on this offense.
