NARRATIVE
On April 6, 2014 at approximately 1407 hours I responded to Rooker Hall in reference to the report of a Burglary. I arrived on scene and made contact with the victime advised on Wednesday April 2, 2014 around 1630 hours he placed his Black "iPad2" (valued at \$400.00) and Black leather "iPad" case (valued at \$50.00) in the Track and Field Locker room at the coliseum annex. advised when he returned to the locker room around 1715 hours his iPad2 and the case were not there anymore. Total loss of value is \$450.00. advised that the case had a "G" on the front of it. was able to provide the serial number for the iPad and it was assigned NIC number A771971815. The locker room access is controlled with a fingerprint device which only opens for people associated with Track & Cross Country team, once the door is closed it then resecures and the only way for it to reopen is through fingerprint access. did not state that there were any signs of forced entry into the locker room. On 04/07/14 I spoke with a member of the coaching staff by the name of who advised that every "now and again" the door malfunctions and may not close properly but was unsure if the door malfunctioned during the time this incident occured. When I went to the Men's locker room on 04/07/14 the door seemed to be working properly.

This information is intended to be part of the original report for this incident.

On 04/18/2014 at approximately 0900 hours I met with Judge Makin of the Athens-Clarke County Magistrate Court and presented him with one misdemeanor arrest warrant for the charge of Theft by Taking.
