Notes/Narratives

NARRATIVE

On 12/07/12 at approximately 0254 hours, Athens-Clarke County Police received a report of a hit and run accident which had occurred on Bloomfield Street near Cloverhurst Avenue. I was advised that a vehicle had reportedly struck a utility pole and had left the scene. Athens-Clarke County Police responded to the area and began an investigation. At approximately 0310 hours, University of Georgia Police dispatch received a report from University of Georgia Housing Security [REDACTED] that he had discovered a 2006 Chevrolet Silverado [REDACTED] parked in the Boggs Hall Parking Lot and that the vehicle was missing the left front tire and wheel. I responded to the area and the reporting party [REDACTED] directed me to the vehicle. I approached the vehicle and noted visible damage to the vehicle in the form of denting and scratching to the left front quarter panel and the missing left front tire and wheel. I also noted heat coming from the engine compartment which seemed to indicate that the vehicle had been recently driven. A check of University of Georgia records revealed that the vehicle's license plate information cross referenced to a University of Georgia student (Pfister, Cody A [REDACTED]). UGA records indicated that Pfister lived in [REDACTED] Boggs Hall. I advised ACCPD officers (Officer Waindle and SPO Hogan), who had arrived on scene, of this information and my observations. I offered to escort them to [REDACTED] Boggs Hall in order to further their investigation by attempting to make contact with Pfister. I accompanied ACCPD officers to [REDACTED] Boggs Hall. ACCPD officers knocked loudly and repeatedly on the doorway to [REDACTED] but no one came to the door. ACCPD officers advised that this would conclude their investigation at this time and unless Pfister called them at a later date and time they would be taking no further action for this incident.

A welfare check was conducted to check on the welfare of Pfister. Pfister was transported to Athens Regional Medical Center per his request for treatment of a laceration to his left hand. Upon further investigation Pfister was placed under arrest while at Athens Regional Medical Center for driving under the influence of alcohol and drugs. Pfister was read the Georgia Implied Consent Notice for Suspects Under Age 21 in which a blood test was requested for the state administered chemical test. Pfister refused to submit to the state administered chemical test of his blood. A search warrant was sought and obtained for a sample of Pfister's blood. Blood was drawn from Pfister by ARMC personnel. A search warrant was also obtained for Pfister's vehicle. Upon executing both search warrants, further investigation, and the seizure of evidence. Pfister was charged with the following offenses:

Pfister was transported to the Athens-Clarke County Jail and he and his property were released to ARMC personnel.
