NARRATIVE

On February, 01 2013 at 0350 hours I was dispatched to Creswell Hall in reference to a report of an intoxicated male in the lobby. Upon my arrival I met with Jason Still (University Housing Security). Still stated that the individual later identified as Shahil Kirankumar Patel tried to gain access to Creswell Hall using his credit card. Still also stated that the individual appeared intoxicated with a strong smell of alcohol on his person.

I made contact with Patel and I asked him what was going on and why he was in this situation. Patel stated that he was having family issues with alcohol and that he was out downtown drinking. I asked Patel to show me his Georgia Identification and he stated he did not have one. I asked Patel if he would consent to me looking in his wallet and he agreed. I noticed a Georgia Driver's License (OLN [REDACTED] belonging to [REDACTED]. A check of GCIC confirmed the license to be valid with the date of birth of [REDACTED]. I asked Patel whose driver's license was the one I found in his wallet, Patel admitted that the valid driver's license belonged to his cousin and he uses it to get access into bars in downtown Athens. Patel also stated that he uses the Georgia driver's license in question to buy alcohol.

A check of GCIC also revealed that Patel's birthday is on January 3, 1994 and he admitted he was 19 years of age. Patel stated that he was drinking in downtown Athens and he knew he was wrong by doing it. While speaking to Patel, I smelled a strong odor associated with alcoholic beverages coming from his person. Patel was placed under arrest at 0405 hours for Underage Possession of Alcohol (3-3-23) and Possession of Fraudulent ID (16-9-4). Patel was searched incident to arrest and was placed in double locked handcuff behind his back and seat-belted in the back seat of my patrol vehicle to be

transported to the Clarke County Jail.

After reading Patel his Miranda Rights I asked if he could provide a sample of his breath, Patel refused.

At the Clarke County Jail Patel was turned over to deputies for processing along with his belongings which consisted of a cell phone, a brown leather wallet with its contents, a set keys and a phone charger. Patel was issued a copy of his Underage Possession of Alcohol citation (#035725). This incident was recorded on the MVR in vehicle 95115. The valid Georgia driver's license (OLN 053571158) was placed in evidence locker #010 to be held for trial.
