NARRATIVE

On 032813 I was on patrol on Barnett Shoals Rd. I observed a vehicle traveling towards Gaines School at 61 mph. I confirmed this with my radar unit, got behind the vehicle and caught up at the intersection with Gaines School. The vehicle turned right and I activated my emergency lights to initiate a traffic stop. The driver continued to the shopping center entrance beside Chik Fil A. The driver turned right in front of Papa-Johns, went around the building and parked in a parking stall.

I made contact with the driver, identified as Jonathan Poole Jr. As he spoke I could detect the odor of an alcoholic beverage on his breath. His eyes were red and glassy. I asked where he was coming from and he said from a friend's fraternity house. He had a paper band around his right wrist, similar to the ones used by bars. I asked about that and he said that he had been at an event. He said that he had two beers there. He stated that he had those beers at around 10:00 pm. I told him that I stopped him because he was traveling 61 mph in a 40 mph zone. He stated that he had no idea that he was going that fast. I asked if he felt that he was a safe driver and he replied yes. I asked if he would be willing to do some tests for me and he said yes.

I turned off the front strobe lights on my patrol car. For the test I used a white parking stall line in an area that was flat, dry, level and well lit. He reported no problems with his eyes and he was not wearing contacts. During the HGN portion of the test I had to tell him several times to hold his head still and only move his eyes. SFST results were:

HGN:

Checked equal pupil tracking and pupil size (looked ok)

A lack of smooth pursuit (present in each eye)

Distinct and sustained nystagmus at maximum deviation (present in each eye)

Onset of nystagmus prior to 45 degrees (present in each eye)

Observed 6/6 clues

Walk and turn * Mr. Poole was wearing western style boots with a 1 " heels . He elected to keep them on.

Lost balance during instructions (stepped to the side to maintain balance)

Started too soon

Stepped off line

Missed heel to toe by more than inch

Improper turn

Mr. Poole blew into an Alco-Sensor for a reading of .15. I asked again about the amount of drinks. He had the first at 10:00 pm and the last at 11:30pm. He was drinking Terrapin beer, again stating that he only had two beers.

I placed Mr. Poole under arrest for DUI and told him so. I placed him in the rear seat of my patrol car, and leaving the door open read him the Georgia Implied Consent Notice (orange card) for suspects age 21 or over, specifying breath for the state test. He stated that he would take the state test. At Mr. Poole's request his vehicle was left secured where it was. I transported him to East PD for the state test.

I performed the test (permit number 40075) on an Intoxilyzer 5000 (serial # 68-001034). Results were .157 and .148. I transported Mr. Poole to the ACC Jail. There I issued him citations for DUI (337823) and Speeding (337824). I completed a 1205 form, explained it to him and provided him with the yellow copy. He was turned over to the SO.

NARRATIVE

On 03/28/13 at 0210 hours, I was inside of the Lay-Z-Shopper convenience store and was informed by the store manager [REDACTED] that he observed a white male attempting to shoplift. [REDACTED] pointed out the white male to me, at which time I observed him attempting to hide behind another male in the candy aisle. ~~The suspected white male then grabbed a beef jerky stick off of the shelf and proceeded to open it, discarding the wrapper on the floor. I observed the white male trying to discreetly eat the jerky while standing behind the other male. [REDACTED] informed me that he wanted to confront the suspected white male and asked me to escort the male to the register to address the potential shoplifting matter.~~

Upon having contact with the white male, I noticed that he was highly intoxicated (strong odor of an alcoholic beverage coming from his breath, slurred speech, and poor motor skills). The male was identified via his license as Timothy Taylor [REDACTED] 93. While at the register, [REDACTED] asked Taylor if he was going to pay for the jerky, at which time Taylor responded by tossing the jerky at [REDACTED]. Taylor was placed under arrest and charged accordingly.

While I was escorting Taylor outside, another intoxicated white male approached me, yelling expletives at me. I had contact with that male and he was identified as Alexander Croy [REDACTED] 93. Croy also had shown signs of impairment as result of alcohol consumption (strong odor of an alcoholic beverage coming from his breath, loud slurred speech, and poor motor skills). Croy was placed under arrest and charged accordingly.

Both males were transported to the Clarke County Jail.

NARRATIVE

On 032613 at 1548 hours I was dispatched to Hill Hall in reference to the smell of marijuana coming from room [REDACTED]. Upon my arrival at 1555 hours I made contact with the reporting party, [REDACTED] (Residence Hall Director), who led me to the second floor south wing of Hill Hall. I approached room [REDACTED] and based on my knowledge, training, and experience I was able to recognize the odor as that of burning marijuana. I have been trained on the smell of burning marijuana through several training sessions where I was exposed to burning marijuana which has been tested and certified by the G.B.I. Crime Lab. I was able to make contact with the residents/occupants of room [REDACTED] Jin Lee and Eugene Kim. As soon as the door to room [REDACTED] was opened, I smelled a strong odor of burning marijuana coming from room [REDACTED]. Consent to search the room was denied by both residents. A judge signed a search warrant for room [REDACTED] and subsequent investigation led to the arrest of Lee and Kim for possession of marijuana less than 1oz. Lee and Kim were placed into the rear seats of my patrol vehicle and secured with a seatbelt. Lee and Kim were transported to the Clarke County Jail and released to Deputies at the Jail along with their personal belongings. Evidence obtained during the search was placed into evidence locker number 015 at the University of Georgia Police Department. The marijuana which was seized on scene was subjected to a presumptive field test for marijuana and it tested positive by color change. The marijuana was weighed and it weighed less than 1 ounce. [REDACTED] was given a case reference number on scene. The following items were seized from room [REDACTED] of Hill Hall:
