On July 15, 2013 at approximately 1123 I was dispatched to First American Title Lending located at 2235 W Broad Street in reference to interference with security interest. When I arrived on scene I met with the reporting party William Lovette.

Mr. Lovette advised me that his company loaned the suspect [REDACTED] money on December 27, 2012. He said [REDACTED] used her 2012 Kia Optima as a security interest. Mr. Lovette said the last payment made to [REDACTED] account was on May 2, 2013. He said her remaining outstanding balance is \$6448.13. Mr. Lovette has made several attempts to contact [REDACTED] by mail, phone and in person. He said he has not had any contact with [REDACTED] or the vehicle.

Mr. Lovette advised he is familiar with the pre warrant application process and will be seeking warrants for [REDACTED] in reference to code section 16-9-51. I provided Mr. Lovette with a case number.
