Notes/Narratives

NARRATIVE

On 093012 at 0452 hours I responded to Building 1516 in reference to an intoxicated person. I met with the complainant in the lobby of Building 1516. The complainant (Little, Justin [REDACTED]) stated that Chris Crockett (Hall Director [REDACTED]) called him to the lobby in reference to a person that was having trouble with a key. Crockett stated that the individual (Spragins, Charles [REDACTED]) seemed ok when he arrived to the building. Crockett stated that he was able to scan his ID card to get into the building. Crockett stated that Spragins came back to the lobby area and started talking nonsense. Crockett stated that Spragins stated his roommate was out of town and he need to reset the password to get into his room. Crockett then contacted Little by phone.

Little stated that Spragins told him that his roommate was out of town and needed the other half of the key to get into his room. Little stated that he went with Spragins to room 145A to see if his key would work. Little stated that when they arrived to the room Spragins did not have any keys with him. Little stated that they went back to the lobby desk to check out a key for Spragins. Little stated that Spragins could not work the iPad or do any part of the checkout process. Little stated that Spragins went over to some chairs that are set up in the lobby area and started messing with them in which one of the chairs fell over. Little stated that is when he contacted UGAPD.

I asked Spragins where he had been tonight and he stated at a friend's room in Building 1512 and at Bad Manor. I could smell the odor that is commonly associated with alcoholic beverages coming from his breath. I asked Spragins how much has he had to drink tonight and he stated enough. There were several times that Spragins would speak in Portuguese and in Spanish. I would have to repeat most of my questions. Spragins stated that it is legal to drink at the age of 18 in Brazil where he is from and that is what he is used to. I asked Spragins does he know that the legal drinking age is 21 in the US and he stated yes. I was able to determine that Spragins was under the age of 21 by his date of birth of 022093. I then placed Spragins under arrest for Underage Possession of Alcohol (O.C.G.A 3-3-23m). I placed Spragins in double locked handcuffs behind his back. Spragins was searched incident to arrest and then was secured in the back seat of my patrol vehicle. Spragins was issued a citation for Underage Possession of Alcohol (Citation #: 035210) and was released to Clarke County Jail personnel. My MVR was on during this incident.
