NARRATIVE

On 5/31/2013, at 1100 hours I was dispatched to a report of theft by taking. I met with the reporting party, Debra Lovelady, who advised that between 5/21/13 and 5/31/13 an unknown party had unlawfully taken a 48 volt charger belonging to a UGA club car electric golf cart (VIN # A0035-927850).

Lovelady advised that the golf carts are kept behind Brooks hall, and that they are secured to a tree near the rear of the building by a chain, but that the charger itself was not secured and rests inside an open storage compartment on the back of the golf cart. Lovelady stated that the charger is a Lesterlink series, 48 volt charger, with no distinctive markings or VIN number, valued at \$458.

The total loss value for this incident was \$458.00. No GCIC entry was made due to a lack of identifiers. Lovelady received a case reference card. My MVR was not in use for this incident.

[REDACTED] at the time, did not stop and confront the bicyclist. When he returned to work from delivering the food he was delivering he noticed the dent. [REDACTED] told me that the bicyclist had called his place of work in order to complain about him. 

[REDACTED] stated that there may just be a smudge from his hand on his window but no dent.

[REDACTED] stated that according to information given to him by the IRS, the individual using his identity has used it to file taxes in the year 2010, 2011, and 2012. Addresses listed on the tax returns were: 612 Holiday St. Longview, Texas 75601 and Apt 127 600 West Avalon Ave. Longview, Texas 75602.

[REDACTED] stated that other than the use of his name and social security card for tax refunds, it did not appear that any of his other financial accounts had been compromised. [REDACTED] advised that the IRS advised him to get a police report. [REDACTED] was given a case number and advised on how to obtain a copy of the report.

NARRATIVE

On 06/04/2013 at 0428 hours I was dispatched to the Thomas Textile Building at 955 Whitehall Road in reference to an intrusion alarm from inside the building. On arrival I discovered a white Chevrolet Pickup (GA TAG: [REDACTED] with the engine still warm. A check with dispatch indicated that the vehicle was not a positive cross reference. I entered the building through an unlocked door on the southwest side. As I later discovered, both entry doors to the building were unsecure. Inside the building I made contact with [REDACTED] who is not authorized to be inside the Thomas Textile Building. Upon questioning, [REDACTED] indicated that she was homeless and on medication for anxiety and other mental health conditions. [REDACTED] indicated in her statement that she is a client of Advantage Mental Health Services.

[REDACTED] stated that she only entered the building to use the restroom and to obtain temporary shelter. [REDACTED] was wet from bathing her face and hair in the sink of the women's restroom. [REDACTED] could not explain why she came to be at the Thomas Textile building other than by divine intervention. [REDACTED] had no recollection of being in the building before. [REDACTED] completed a four page statement describing what brought her to that particular building on campus.

The contacts for the building were called and stated that nothing inside the building appeared to be disturbed or missing.

[REDACTED] was barred from all of the University of Georgia campus for a period of 2 years for being in the building after hours with no legitimate purpose or authorization. [REDACTED] was notified and signed the barring notice. [REDACTED] stated she understood the notice and was given a copy. Due to the fact that the building was unsecured and no security measures were defeated by her entry and I could not find any
