On 6/23/13 at approximately 2345 I responded to [REDACTED] in reference to the complaint of a door appreaing to have been kicked open at this location. I arrived on scene and met with the caller, [REDACTED]

[REDACTED] said he left town last Monday. He returned just now to find the front door standing open and the lights on inside the building. His friend checked on the residence on Wednesday 6/19 at about 1800. Everything was fine at that time. He has 2 roommates, [REDACTED] They have both been out of town for longer than [REDACTED] was.

The front door of the residence had been kicked in, with damage to the latch and door frame. The cushions on the couch in the living room were in disarray. A 40" Samsung Flatscreen TV, an X-Box 360, and a Sony Playstation 3 had been taken from an entertainment stand in the living room. They all belonged to [REDACTED]

[REDACTED] said he had about \$60 worth of coins in a Crown Royale bag, which was missing from his bedroom.

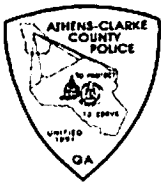
