Notes/Narratives

NARRATIVE

On 06-01-2013 I met with the reporting party, [REDACTED], at the [REDACTED] where she works as a clerk.

Ms. Rutter said that there is a w/m, 603 220 lbs muscular build 35-40 years old, who comes into the store and asks her out on dates. She said she always declines the invitation. She said that the w/m said that he comes by and waits in the parking lot to see if her car is there, then commented that he noticed she had put her UGA Alumni sticker in the rear window. [REDACTED] said this has been going on for about 3 weeks now. She works the day shift from around 0600-1500 daily. It is unknown if he comes in the store after she is off work.

[REDACTED] is now concerned that he may be following her around town and may learn where she lives.

After taking the information from [REDACTED], myself and Lt. Whitmore were out in the parking lot near our patrol vehicle discussing preventive actions we would be taking. Another clerk came outside and said that the w/m had just entered the store and was wearing a red shirt. Myself and Lt. Whitmore remained in the parking lot until the w/m left the store.

Consensual contact was made in the parking lot between the w/m, Lt. Whitmore, and myself. The w/m produced a Georgia driver's license which identified him as [REDACTED] Lt. Whitmore, in a general fashion, explained to [REDACTED] the concerns of the clerks inside the store. It was suggested that when he came to the store, not to engage the clerks in any personal matters because they were becoming uneasy. [REDACTED] acknowledged that and added that really the only clerk he talked with was [REDACTED].

[REDACTED] was NOT barred from the store.

Extra patrol has been set for 3 weeks all shifts reference to this report.
