NARRATIVE

On 090912 at approximately 0235 hours I was on routine patrol on Broad Street. When I came to the intersection of Broad Street and College Avenue I looked over towards the Arches and noticed an individual sitting on the steps. The individual later identified as Kiet Dang Nguyen looked towards my patrol vehicle and yelled out "Fuck you Cops". I parked my patrol vehicle (94828) east of College Avenue and made contact with the individual. Upon initial contact with him I noticed a moderate odor commonly associated with an alcoholic beverage coming from his person and breath. I asked Nguyen if he was having any issues tonight and he immediately stated that he was sorry and just wanted to go home and sleep. I asked Nguyen how much alcohol he had drank that evening and he stated "way too much". I then asked him for his driver's license. He reluctantly gave it to me after asking for it several times. After he gave me his Driver's license I noticed that he had taped a zero over the two in his date of birth in an effort to make it seem like he was over the age of twenty one. I had dispatch perform a check through GCIC of his OLN which confirmed he was under the age of twenty one. At 0237 I placed Nguyen under arrest and searched him incident to arrest but no contraband was found. He was transported to the Clarke County Jail and left along with all of his possessions with Deputy Folkers. He was issued one citation for Underage Possession of Alcohol (034070). There is a MVR recording of the transport.
