On 2/13/13 at approximately 0254 hours, I was dispatched to Russell Hall in reference to a complaint of a strong odor of marijuana in the northern wing of the 2nd floor. Upon my arrival on scene I met with the complainant, Racquelle James, who stated that she could smell a strong odor of marijuana in the hallway and she along with Housing Security had narrowed it down between rooms [REDACTED]. Officer Wood and I could smell a strong odor of marijuana that intensified as we moved down the hall. Officer Wood and I smelled the door frames of rooms 235 and 236 and were able to deduce that the odor of marijuana was coming from room 235.

Officer Wood and I made contact with one of the occupants who denied us consent to search the residence. Corporal Thompson and Officer Haas secured the residence and the occupants while Officer Wood and I secured a search warrant from Judge Auslander for the residence and occupants.

We began a search of the residence at 0521 hours. Evidence was collected and secured in evidence locker #005. No arrests were made at the time of this report, however warrants are pending.

NARRATIVE

On this date I was dispatched to an armed robbery that had just occurred at On The Way Package Store at 1097 Baxter St. Central Communications advised that the suspect was a black male wearing a hat, black pants and black jacket, and was wearing a scarf over his face. They advised that he left on foot and was last seen running behind the neurological center on Baxter St.

Sgt Schuble and other assisting officers began to search the area nearby, while I responded to the store to interview the victim and any possible witnesses. Upon arrival I met with [REDACTED] a owner of the store. He took me inside and let me watch the video of the incident. I observed the clerk vacuuming the store and take the vacuum cleaner out to empty it. When he came back in he was followed by a black male, slim to medium build, wearing dark bluejeans, a black jacket sipped to the top and dark sunglasses, and a camouflage baseball style cap. The suspect also had on white tennis shoes with dark shoe laces and a dark color around the bottom of the shoes. I observed the suspect on the video walk up behind the victim and place a knife in his back and walk him to the cash register. He held the victim at knife point while he removed the cash from the register, [REDACTED] The suspect then fled the store on foot and I observed him running in the direction of the neurological center and Evans St. I radioed the information to units in the area to help with their search.

Next, I spoke to the victim, [REDACTED] He stated he was cleaning up when the suspect came from behind him and placed him at knife point and stole all the cash from the register. He received a large scratch on his neck from the knife. He said that he did not recognize the male, as his face was covered with his jacket. He said he saw the male running from the store until he dissappeared behind the neurological center.

As I was interviewing the victim and all witnesses, Sgt Schuble made contact with a homeowner in the area who told him he saw a male walking quickly down Evans St.. He told Sgt Schuble the guy's name was Miles Griffith. He said that Mr. Griffith had a history of armed robbery. Sgt Schuble called for other units to come over to 287 Evans St. while he asked the homeowner for consent to identify who was in his home. I stood on the back side of the house and held the perimeter to make sure no one came out the windows. This was the extent of my involvement in the case.

The owner of the store made copies of the video and turned it over to us for evidence. All information and evidence was iven to CID for further investigation. Mr. Griffeth was transported to the east precinct by SPO Parker for questioning. He was then transported to Clarke County Jail where he was turned over to the custody of CCSO.

On 130301 I was on patrol on Meigs St. I was about to turn onto Prince Ave when I observed a vehicle traveling westbound on Prince Ave just at Pulaski St that did not have the headlights on. I waited for the vehicle to pass me then I turned left onto Prince Ave. As I did I activated my emergency lights to initiate a traffic stop. The driver turned right onto Barber St. and then left into the second entrance of the Golden Pantry. I made contact with the driver, identified as Adam Cooper. I asked if he knew why I pulled him over and he said because he did not have his lights on. As he spoke I could detect the odor of an alcoholic beverage on his breath. His eyes were red and appeared droopy. I asked where he was coming from and he said Allgood and Nowhere bars. I asked how much he had to drink and he said "2-3 beers". I went back to my car to run the license number and while there I turned off the front strobe on my patrol car.

I asked Mr. Cooper to step out of the car. I could still smell the odor of an alcoholic beverage on his breath when he was away from the car. I asked again how much he had to drink and he said "a couple beers". He stated that his first drink was at about 7:00 pm his last about an hour to an hour and a half ago (about 12:00 am). I asked if he thought he was a safe driver and he said he was confident in his abilities. I reminded him that he was driving without his headlights on. He said that was because he was coming from a bright area. I asked if he would do a standardized field sobriety test and he said yes. He stated that he did not have any eye problems. I used an area by the building that was flat, dry, level and well lit. Test results were:
