NARRATIVE

On February 1, 2013 I responded to 394 Oconee Street (Steeple Chase Apts) in reference to a male subject beating on a door at that location. According to Central Communications the residents (three females) at that location heard a loud banging at the door and sought refuge in a back bedroom where they called for police assistance.

As I approached the area I surveyed the area where I knew the residence was located and did not see anyone immediately outside the apartment in question. I saw a white male wearing a black jacket and khaki pants standing at the entrance to the complex that appeared to have been trying to make a phone call. As I approached I could see the male was unsteady on his feet, a common sign of intoxication. I made contact with the male and he identified himself as Stephen Lambert.

I asked Mr. Lambert where he had been coming from and he told me "the dark apartment." Mr. Lambert then motioned in the direction where the caller's apartment was located. I asked him why he was coming from that direction and was told that he was trying to find his friend that lived in that apartment. According to Mr. Lambert he knocked a couple of times and then started pounding on the door with a closed fist. Mr. Lambert told me that he had come from The Winery downtown where he had a few drinks with friends (later Mr. Lambert clarified he had a few shots and a few beers).

During the course of this investigation Mr. Lambert took a phone call from his friend "Pat" that he put on speaker phone. "Pat" asked Mr. Lambert where he was and when Mr. Lambert told him he was at Steeple Chase "Pat" asked "Why the fuck are you at Steeple Chase?" Mr. Lambert responded that they had been there earlier, to which "Pat" responded "No we weren't."

I asked Mr. Lambert if he was on probation or parole and he told me he was on probation for two DUI

convictions. I asked Mr. Lambert if abstaining from the consumption of alcohol was a condition of his probation and he told me that it was.

When asked how he would feel if that had been his residence he was banging on the door at Mr. Lambert told me he would have been "alarmed."

Officers surveyed the incident location and found that Mr. Lambert had kicked in the door at that location. There was physical evidence, including footprints matching those of Mr. Lambert's shoes to support that Mr. Lambert had indeed damaged the door.

Mr. Lambert was placed in handcuffs (DL/BB), a search of his person was conducted incident to arrest and he was transported to the Clarke County Jail.
