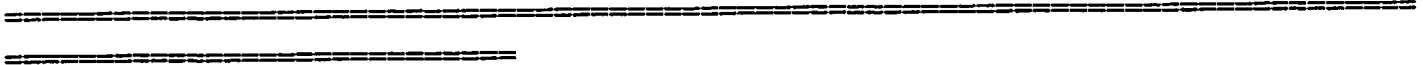
Notes/Narratives

NARRATIVE

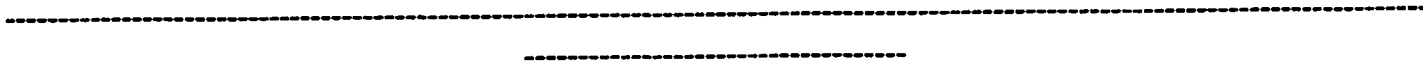
On 03/28/2014 at 0322 hours, I was dispatched to Sanford Stadium in reference to an intrusion alarm. Upon my arrival I made entry into the stadium and made contact with Austin George ([REDACTED]), Jacob Glover ([REDACTED]), and Rian Penrod ([REDACTED]). I made contact with these three individuals in section 114 of Sanford Stadium.

George, the only UGA student, stated that he was told that it was a rite of passage for freshman students to enter the stadium and walk around on the field. George stated that he and his friends, Glover and Penrod, gained entry into the stadium near gate 10 where a piece of the fence is broken. He advised that they used an upside down trash can to help them climb over the fence.

At this time, there is no known damage to the stadium caused by these three individuals. George, Glover, and Penrod were barred from Sanford Stadium for a period of 60 days for Criminal Trespass. The offense of Criminal Trespass is not being pursued and is exceptionally cleared. They were released from the scene with their copies of the barring notices. Photographs were taken of all three individuals.
