## NARRATIVE

On 03/24/14, I responded to 897 S. Milledge Ave., in reference to suspicious phone calls several of the sorority members have received.

Upon my arrival I met with the [REDACTED] of the sorority [REDACTED] [REDACTED] stated several of the younger freshman members received these block calls from a male identifying himself as [REDACTED]. The male identified as [REDACTED] would then inquire about another member by the name of [REDACTED] and when he did not get the information he was asking for, he would hang up.

Speaking to [REDACTED], she stated the male called her from a blocked number. [REDACTED] stated the male said his name was [REDACTED] and she met him through [REDACTED]. She stated the male then asked her about another member [REDACTED]. [REDACTED] further stated he mentioned that a girl is suppose to be setting her up with him.

Speaking with [REDACTED], she stated she also received a phone call from a male identifying himself as [REDACTED]. She stated the male asked if she remembers meeting him through [REDACTED] and after about ten seconds hung up.

After speaking to the first three members, [REDACTED] arrived at the sorority house and stated she also received a call from this guy [REDACTED]. She stated the male said "hi [REDACTED] this is [REDACTED], I'm a friend of [REDACTED] and we met in Athens, I go to Ga Tech". "[REDACTED] is trying to set me up with [REDACTED] can you describe her to me". [REDACTED] stated she informed the male that she didn't know [REDACTED] but that everyone likes her. [REDACTED] stated she also informed the male that [REDACTED] was on Facebook if he wanted to look her up.

[REDACTED] stated the male then wanted her to describe [REDACTED] body type, at that time she did not feel comfortable doing so and ended the conversation.

[REDACTED] provided some additional information stating that [REDACTED], had received a pornographic video via text from the same male. She said this male would also call [REDACTED] breathing heavy then hang up. [REDACTED] provided me with the phone number [REDACTED]

[REDACTED] was unavailable to speak with today, but was informed through [REDACTED] to call the police department about this incident.

A housecheck has been setup at this sorority for one week all shifts reference to these suspicious phone calls.
