NARRATIVE			
On 11/5/13 I was dispatched to a robbery that just occurred at			
While en route to that location Central Communications updated me with the suspect information. They said that it was a somewhat taller white male around the age of 19-22, with light brown hair, carrying a large dark blue ADIDAS duffle bag.			
I met with who stated that she had a short confrontation with a man in the parking lot in front of her apartment. She stated that she pulled into the complex and a white male, later identified as Samuel Friedman, approached her vehicle. He first asked her if she could give him a ride to Franklin's (a gun store on Atlanta Hwy), but she said no. Then he asked her if he could use her cell phone (a black iPhone 4) to make a phone call because he did not have one. Stated that she typed in her passcode, and Samuel was watching very intently. Mends. The next thing she knew, he grabbed the phone out of her hands, began to run away, and said "I will kill you for that phone". Began to chase after him down Pope St. while yelling at him to give her phone back. Eventually, Samuel stopped and placed the iPhone on the ground and told "I just wanted to see how good of shape you were in". Then retrieved her phone, and ran back to her apartment to call 911. Seemed to be a very strong willed and determined person. The way she described the robbery, it seemed as if she was not going to let Samuel get away with taking her cell phone. She described being very close to him the whole time they were in a foot chase.			
While speaking with UGA was able to make contact with a male subject matching that description at the Off Campus Bookstore on Baxter St. I brought over to the bookstore so she could identify the suspect. When we got there, she said that it was definitely him, especially when she was able to observe his hands.			
I went to speak with Samuel, and UGA told me that he already admitted to taking seems s cell phone to them (See UGAs case number 13-2624).			
filled out a statement form to describe what actually happened during the robbery, this will be placed into the completed forms box.			
I then placed Samuel under arrest (double locked/behind the back) for robbery. I searched him incident to arrest and found a brand new Google Nexus cell phone in his pocket. I placed him into the back of my patrol vehicle, and read him Miranda (laminated blue card). He said that he did not want to speak

At one point in the vehicle he was rambling and said something along the lines of "I was only talking to the bitch and asked for her phone because she looked identical to that other girl".

I finished transporting Samuel and released him to CCSO.

I placed the blue duffle bag into evidence. Inside the bag were several items that appeared to be drug related. Those items include a grinder, a digital scale, and a container that had residue and the odor of marijuana and incense (possibly synthetic). Also, there were many items that looked to be broken up sticks of incense. Those items were placed into evidence as well. The other items from the duffle bag were placed into evidence for safekeeping.
