NARRATIVE

29 September 2013 I took a call by phone in reference to an incident that occurred downtown last night, following a home football game.

Victim [REDACTED] called from Atlanta; he had already left Athens and was unable to meet in person. He explained that he had been in Athens for the football game previous date and went downtown to enjoy the post-game festivities. At around 0100 he was walking on Washing St in the area of N Jackson St. He had just gotten separated from a friend he was with and was walking alone. He said he had been drinking and was intoxicated and having a little trouble walking. He tripped and fell. Two men took hold of him and started to help him up to his feet. [REDACTED] thought they were just being helpful, but when they had him about half way picked up, one of the men reached into [REDACTED]'s pocket and pulled out his wallet. Before [REDACTED] was able to react, the two men ran away on foot on Washington St (they split up and ran in opposite directions from one another). [REDACTED] said he was in shock from the incident and returned to his hotel, where he retired for the evening.

[REDACTED] described both the suspects as young black males, possibly early 20's or younger, tall and thin with a somewhat athletic build, short hair, medium complexion, unknown clothing description. [REDACTED] did not notice any apparent facial hair, scars or tattoos. The incident happened very quickly.

[REDACTED]'s wallet was a black leather card holder type wallet with a money clip attached to the back and a plastic viewing window for an ID card on the front. It contained his GA driver's license, an American Express Delta Skymiles credit card and two VISA check cards. He has already contacted his banks.

I gave [REDACTED] a case number over the phone.

NARRATIVE

On 09/27/13 at 1709 hours, I was flagged down by [REDACTED] on the south side of the Coliseum along Smith Street. [REDACTED] said a pane of glass had shattered and fallen out of the exterior lobby glass wall of the Coliseum. Much of the shattered glass was still in the window frame when I was on scene. However, some of the shattered glass had fallen on the scaffolding below and onto the sidewalk and road.

I used police tape to barricade the sidewalk along the south side of the Coliseum to keep anyone from walking in that area until [REDACTED] could get the remaining shattered glass removed from the window pane and get the shattered glass along the ground removed.

I took photos of the glass. The pane was on the second row from the left and was the third one down from the top. I could not determine what had caused the glass to shatter.

I met with an employee who gave me a purse. I looked inside the purse and it had a Driver's License and an UGA ID. I looked the name up in the UGA Directory to get contact information for [REDACTED]. I called her to tell her that I found her purse. She stated that her wallet and her white iPhone 4s was in the purse. I stated that both of those items were not in the purse anymore. [REDACTED] stated that she was down town over the weekend, but does not recall any specific location that she misplaced her purse.

I gave [REDACTED] her case number over the phone for her records.
