## Notes/Narratives

### NARRATIVE

On 090212 at approx 0127 I was standing in front of the Cloud Bar when I looked to my left and saw a male, later identified as Bradley Tarantino, standing in between two cars off the sidewalk out into the parking spaces. I made contact with Tarantino while he was still holding a half full Bud Light bottle and asked him for his ID. Tarantino opened his wallet and handed me a driver's license for Daniel Bowden ([REDACTED]). I looked at the photo on the driver's license and could tell that it was not Tarantino. I told Tarantino that the license that he had given me was not his and asked him for his real ID at which time he gave me his correct driver's license that proved that he was under 21 years old. I placed Tarantino under arrest for the underage possession of alcohol. I cited Tarantino for underage possession of alcohol, open container, and unlawful use of an ID. I released Tarantino to a transport unit for transport to the jail where he was released to Sheriff's personnel.
