Notes/Narratives

NARRATIVE

On December 1, 2012 I was riding with SPO Simms through the parking lot between Kroger and Schlotzky's Deli when I observed a Jim Beam liquor bottle sitting in plain view in the cup holder of a black open door Jeep Wrangler. The Jeep was parked at the end of the row with its passenger side door facing Schlotzky's. I approached the vehicle and confirmed that the bottle was Jim Beam. I could see that the level of the liquid was lower than it should be if the bottle had not been open. SPO Simms identified the driver/owner, Thomas Griffin, and made sure that he was 21 years old. SPO Simms verified the vehicle belonged to Thomas. Thomas said that he was waiting for two of his friends to come out of Kroger. SPO Simms asked him to put the bottle in the front glove box compartment and lock it while he drove to wherever he was going. When Thomas put the bottle in the compartment, SPO Simms noticed a metal grinder that is commonly used to grind marijuana in the cup holder under a pack of cigarettes. At that time I began to search the vehicle. While searching I found a clear ziploc bag with a green leafy substance (marijuana) in the center console.

Mr. Griffin was placed under arrest for Possession of Marijuana (misdemeanor) and Open Container (6-3-12).

Pictures were taken of the evidence.

Per request of the driver/owner vehicle was turned over to one of the friends that came out of Kroger.
