Notes/Narratives**NARRATIVE**

I was dispatched to 377 Oak St in reference to a call by [REDACTED] that his wife and her boyfriend put guns on him and took his white 2012 Volkswagen CC. While on the phone [REDACTED] advised central the individuals who took his car were now leaving and heading towards the bypass. [REDACTED] advised he was in silver Mitsubishi Mirage and following them. [REDACTED] told central he believed she was going back to Statham. While talking to central, [REDACTED] advised he had lost a visual on the car and would meet with police in the parking lot of the Waffle House on Oconee St. Upon my arrival I did not observe a Mitsubishi Mirage. Central advised their attempts at call back went to voicemail.

A short time later [REDACTED] called central and advised he had just been carjacked by his wife and her boyfriend. [REDACTED] advised he was on foot. [REDACTED] advised central his wife's name was [REDACTED] and only knew her boyfriend as [REDACTED]. [REDACTED] advised he was now at [REDACTED]. While enroute to [REDACTED], Westside units advised they were behind the Volkswagen and shortly thereafter got into a foot chase with the occupants of that vehicle.

Upon my arrival at [REDACTED] I spoke with [REDACTED]. [REDACTED] told me he drove his Volkswagen into the Church's chicken parking lot. Just after [REDACTED] pulled into the parking lot, [REDACTED] her boyfriend [REDACTED] and a second male also pulled into the parking lot. Curry got out of the car and told him, "I told you I was gonna kill you." [REDACTED] and the second male all brandished guns. [REDACTED] advised he ran away from the scene.

CID was notified and I transported [REDACTED] to East PD to be interviewed. [REDACTED] was turned over to CID upon my arrival.
