NARRATIVE

On 10/30/2013 at 1924 hours I was dispatched to a car fire called in by ACCPD to the parking lot near Butts-Mehre Building. Officer Lynn arrived on scene and advised the car was parked on Rutherford Street across from the practice field. I arrived on scene and found the hood of a beige 2005 Mercury Marquis ([REDACTED]) on fire along with the shrubbery in front of the vehicle. ACCFD arrived on scene 1927 hours and was able to extinguish the flames. The owner of the vehicle was identified as [REDACTED]. The fire department stated the fire was mostly caused by an electrical issue. Next in line towing was requested per [REDACTED]. Michael with Shuman's towing arrived on scene at 1949 hours and removed the vehicle. [REDACTED] was notified and arrived on scene at 2015 hours to assess the damage to the property. The area of shrubbery that was burnt is approximately 15' x 10.5'. [REDACTED] was issued a CRN card. Photos of the vehicle and property were taken. Flex camera footage is available.

NARRATIVE

On October 30, 2013 at approximately 1335 I was dispatched to Towne Club Apartments located at [REDACTED] in reference to an entering auto. When I arrived on scene I met with the victim, [REDACTED].

[REDACTED] advised me that she parked her vehicle at this location at approximately 0200 this date. She said she was certain that she locked her vehicle doors. She said she returned to her vehicle at approximately 1200. [REDACTED] said she discovered that someone had broken into her vehicle. She said the only item missing was a portable car charger for her iPhone 5.

[REDACTED] had been through the vehicle prior to my arrival. She advised that all of her door locks and windows were functioning. She said she observed some scuff marks on the rubber near the base of the driver's door window that was not there before. Due to contamination I was unable to process the scene.

[REDACTED] advised that she was not going to file a report since the only item taken was a cell phone charger. She said that she called the police to file a report at the request of the apartment complex management. She said that she does not know who would have done this.

NARRATIVE

On October 29, 2013 I responded to Kappa Alpha Fraternity 755 W. Hancock Ave. Athens-Clarke County, GA., on the report of damage to a vehicle.
