NARRATIVE

INCIDENT RECORDED ON DIGITAL RECORDER AND IS ATTACHED

SOME OF INCIDENT RECORDED ON ARBITRATOR

I was working the road check reference to case number 12-06-1961 at E Campus Rd. and Green St. on UGA campus. I was checking traffic that was coming from the downtown area going toward the UGA Ramsey center. I had been checking traffic here for approximately thirty minutes. I had made contact with several drivers already while posted at the check. The offender vehicle approached and I spoke with the driver (Crowell). I asked him why he did not have his seatbelt on and he said that he had taken it off to reach for his things while approaching the check. I detected the odor of marijuana coming from inside the vehicle. There were five males total inside. I asked him if there was any marijuana in the vehicle and he said no. He said they had been at the club (Aftermath) and that is probably where the smell was from. I asked him if there had been marijuana in the car that had already been smoked up, and said no, and gave the same excuse as having been at the club. I directed him to pull over to the bus lane so that he would be out of the roadway.

I approached him and asked him to step out of the vehicle. I asked him if he minded if I checked his person and he consented. I did not locate any contraband on his person so I had him move to the rear of the vehicle and stand with Officers Carroll and T. Scott. They were there to assist me due to the amount of people in the vehicle. I then went to the back left and had Harrow step out. I performed a consent search of his person and no contraband was located. While searching Harrow, I heard Sgt. Scott say to Crowell "why are you so nervous?" Officers Carroll and Scott provided supplemental reports about the behavior and demeanor that Crowell displayed while I searched the vehicle.

I then had Tibbs step out from the middle seat and performed a consent search. Dawson was searched next from the back right seat. After searching the persons of the back seat occupants, I searched the rear seating compartment. I did not locate any contraband in the rear area. I then went to the front passenger, Clemons, and consent searched him without locating any contraband. I continued to smell the odor of marijuana throughout

my contact with the vehicle and the occupants. Once done searching the occupants, I completed the search of the vehicle by checking the front seat. Crowell had already stated that the vehicle was his. I checked the passenger seat area and did not locate any contraband. I then went to the driver side. I leaned down and looked under the driver seat and just under the driver seat I located a black handgun. There was wire and metal under the seat but the handgun was near the front, closest to the floor mat side. I retrieved the handgun and noticed that the serial number was scratched completely off. The gun was a Luger 9mm. I placed Crowell under arrest. I read him Miranda and he said he wanted to talk. He said that other people drive his car. I asked, other people like those guys in there now, and he said no, other people. He denied knowing the gun was there.

I released the other occupants of the vehicle and Crowell gave permission to one of them to drive the vehicle away. I asked him if he had a handgun permit and he said no. I transported him to the jail. I asked Central to run a criminal history and they said there was none. I released him to the custody of the jail. I searched my rear seat prior to and after placing Crowell there.
