Notes/Narratives

NARRATIVE

On 103013 at 2241 hours UGA dispatch received a call from [REDACTED] at Rooker Hall in reference to the odor of marijuana coming from the area of room [REDACTED]

At 2242 hours I was dispatched to the scene. I arrived on scene at approximately 2248 hours and met with [REDACTED] in the lobby of Rooker Hall. [REDACTED] escorted Ofc Hickey and I to the area she believed the odor to be coming from. [REDACTED] stated that she was unsure of exactly which room it was but that she was aware of incidents of marijuana odor coming from room [REDACTED]. I was able to determine that the odor was coming from room [REDACTED].

I knocked on the door several times. After Ofc Hickey knocked, an individual inside the room asked who it was. Ofc Hickey responded that we were with the police department. The door opened and we made contact with Justin Bernard Wesley ([REDACTED]). I asked Wesley to step out into the hall and asked if there was anyone else in the room. Wesley initially stated no then he stated that his girlfriend was in the room as well. I instructed her to step out into the hallway. Ofc Hickey identified her as [REDACTED]. [REDACTED] was cleared of any wrongdoing in this incident.

I asked Wesley if he knew why we were there and he said "smoke." I stated marijuana and Wesley denied that what we smelled was marijuana. I then explained to Wesley that we were called to the area because of the smell of marijuana and explained that we could smell it coming from his room and asked if he had any inside. Wesley stated no. I asked again. Wesley again denied having any marijuana in the room. I asked Wesley if we could search his room and he stated again "There's none in there." I asked him again if we could search and he responded inaudibly. When I asked for clarification as to whether or not he stated yes or no, Wesley again stated "There's none in there." I asked "Would you be willing to let us search the room, because we can smell it coming from the door?" Wesley stated "It's all gone." I responded by asking if there had been some in the room and Wesley stated yes, explaining that he had smoked it earlier in the day. When asked when he stated around 3 or 4. I asked if he would let me search and he again stated "There's none in there." I explained to Wesley that I was asking him a yes or no question and he again stated "There's none in there." I then explicitly declared my request to search his room and asked for a yes or a no answer. Wesley responded "For marijuana?" and I stated yes. At this time Wesley agreed to a consensual search. I then gave Wesley a "Consent to Search" form and instructed him to read the form so he understood what I was requesting and what his rights were during this portion of my investigation. At this time I had not identified Wesley and after reading the name tags on the door I asked if he was "Justin" or "[REDACTED]" ([REDACTED]). Wesley responded that he was "Justin." I then identified him by his full name (Justin Bernard Wesley) and the consent to search form was signed by the both of us.

Notes/Narratives

I allowed Wesley, who was on crutches, to enter the room with me and sit on the couch while I began the search. Wesley declared what area of the room was his. I asked Wesley how he had smoked the marijuana (pipe, rolled, etc) and he stated with a pipe. I asked Wesley if he had a pipe in his room and he stated "yes."

I began my search and after looking through the desk located in his room I found a black and clear glass smoking pipe with suspected marijuana residue and a silver grinder with suspected green marijuana in the right side top drawer. I requested Ofc Hickey bring a camera so we could photograph the items in their found positions. After taking photos I removed two small red Ziploc baggies containing an unknown substance. I asked Wesley what it was because it had no distinct smell and he stated it was ash. It appeared to be burnt and was similar to the contents of a burnt cigar found on his desk. I did not further investigate these items. I opened the grinder and immediately detected the odor of green marijuana. There was evidence of the marijuana inside the screen of the grinder. I asked Wesley if the pipe I found was the one he used to smoke the marijuana and he stated "yes." I then asked if he used the grinder I found to grind his marijuana and he again stated "yes."

I again asked Wesley if he had any marijuana in the room and he stated no. I did not smell any green marijuana and the odor of burnt marijuana had dissipated by this time. I then concluded my search. Based upon Wesley's admission to having smoked marijuana during the day, the odor of burnt marijuana coming from the room and his admission to using both the pipe and grinder for the purpose of smoking the marijuana, Wesley was charged with Possession of Marijuana less than 1oz (16-13-30) and Possession of Drug Related Objects (16-13-32.2). I then explained to Wesley that I would be taking the items I found but that due to his cooperation I would not be taking him to jail for at this time. I explained to Wesley that the next step would be to take out warrants for his arrest and that when it happened he would be receiving a phone call from either the UGA Police Department or the Clarke County Sheriff's Office to inform him that it was being executed.

I then gave Wesley a CRN (13-2576) card and left the scene.

The confiscated evidence was placed into evidence bags and secured into evidence locker #010 at the University of Georgia Police Department.

A field test was performed on the contents of the grinder using a KN Reagent Fast Blue presumptive test and a positive result for the presence of THC was shown.

Video of this incident was captured using my body worn Taser Flex Cam and by Ofc Hickey's Taser Flex Cam.
