On 04-21-13 at approx. 1030 Hrs. I responded to 1 press Pl to meet with [REDACTED] in reference to someone breaking a window and entering the building.

Upon arrival [REDACTED] advised that he manages the building and when he came this date he discovered that someone had kicked out a window at the rear loading dock. He also showed me some video of the person entering the building.

The suspect appeared to be an intoxicated college student. He was approx. 510-600 foot tall weighing approx. 165-180 pounds. He was wearing a light blue long sleeve button down shirt and dark colored dress pants. He also had on a light colored tie. The suspect walked into the loading dock area from Foundry St and appeared to look around with a female college student. The male then walked up the stairs at the rear door and kicked in a small window and then entered the building. He then went up another level of stairs, looked in an office and then exited a door on the East Broad St side. Nothing was taken from inside the building.

I dusted for prints but was unable to find any that would be usable.

The victim stated that the incident occurred between 041813 at 2000 hours and the time that I found the damage. The victim stated that nothing was missing from the vehicle. 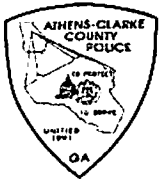
