NARRATIVE

On October 21, 2012 I was patrolling the area of Barnett Shoals Road and Dekle Drive when I saw a blue Subaru failing to maintain its lane. at one point the right hand wheels were traveling fully in the bicycle lane of the roadway. I attempted to initiate a traffic stop on the vehicle; however the driver was slow to respond to my signal to stop from my emergency equipment. Once the vehicle pulled into a residential parking lot I was able to make contact with the driver who identified himself as Cameron Kelly. I explained the reason for the stop and Mr. Kelly seemed to have been unaware of his violation. I noticed the odor of an alcoholic beverage coming from within the vehicle. I asked Mr. Kelly how much he had to drink that night and he told me he had two beers while at 9D's bar downtown. Mr. Kelly further explained that he hadn't had anything to drink for about one and one half hours prior to this investigation.

I asked Mr. Kelly to step out of the vehicle and he complied. I asked Mr. Kelly if he was willing to submit to SFST and he consented.

HGN - (6 Clues) watery and red eyes
 Lack of smooth pursuit - present in both eyes
 Distinct and sustained nystagmus at maximum deviation : present in both eyes
 Onset of nystagmus prior to 45 degrees. present in both eyes at about 35 degrees

Walk and Turn- (2 Clues)
 Raises arms
 Improper turn

One Leg Stand- (2 Clues)
 Arms for balance
 Swayed while balancing

PBT - Positive for alcohol (.100)

Mr. Kelly was placed in handcuffs (DL/BB), a search of his person was conducted incident to arrest and he was placed in the rear seat of my patrol vehicle. Mr. Kelly was read implied consent for persons over 21 years of age and he agreed to the State's request for his breath

At his request his vehicle was left secured at the scene.

Mr. Kelly was transported to East Police Headquarters where I administered the State's test resulting in (.115) and (.116).

Mr. Kelly was transported to the Clarke County Jail
