On February 1, 2013 at 2251 hours I responded to Boggs Hall in reference to a report of underage consumption of alcohol. Upon my arrival I met with [REDACTED] who stated that he met with another resident advisor, [REDACTED] who was speaking with Owen Hunt [REDACTED] who was holding a 40oz bottle of Icehouse. [REDACTED] and [REDACTED] advised Hunt that he needed to stop and pour out the alcohol. [REDACTED] and [REDACTED] advised that Hunt went into room [REDACTED] with the alcohol and shut the door behind him. After [REDACTED] and [REDACTED] knocked several times Hunt finally exited the room without the bottle. [REDACTED] and [REDACTED] asked Hunt what he did with the bottle. Hunt then returned to the room and retrieved the bottle and set the bottle down in the hallway. [REDACTED] and [REDACTED] advised that sometime during their conversation with Hunt two males and one female exited the room. None of the individuals were residents of Boggs Hall.

I first spoke with Hunt. Hunt advised me that his friends were the residents of the room and they had allowed them to stay in the room while the residents of the room were away. I asked Hunt if he had drank any alcohol this evening. Hunt stated that he had some alcohol to drink this evening. The odor commonly associated with an alcoholic beverage was coming from Hunt's breath. I then spoke with Charles Woods. Woods' face was flushed; eyes blood shot, and speech slurred. The odor commonly associated with an alcoholic beverage was strong on his breath and person. I asked Woods what he was doing this evening and he advised that he was hanging with his friends. I then asked Woods if he had any alcohol this evening and he stated no. I asked Woods if he had been arrested before due to him having court order papers in his wallet. Woods advised me that he had been arrested for underage possession of alcohol before. The remaining two individuals, [REDACTED] and [REDACTED], denied having alcohol and had no odor commonly associated with an alcoholic beverage on their breath or person. [REDACTED] and [REDACTED] were released.

Due to Hunt admitting to drinking alcohol and possessing the 40oz bottle of Icehouse, the odor commonly associated with an alcoholic beverage coming from Woods, and the 40oz bottle of Icehouse found at the scene, I placed Hunt and Woods under arrest for underage possession of alcohol 3-3-23 (Citation #'s: 037817 issued to Hunt, 037816 issued to Woods). Hunt and Woods were placed in double lock handcuffs behind their back and were searched incident to arrest. No contraband was found after searching Hunt and Woods. I read Hunt and Woods the Miranda Warning. Hunt and Woods stated they understood what had been read to them. I asked Hunt and Woods if they would provide a breath sample, both declined. I placed Hunt and Woods in the back seat of my patrol car. Hunt and Woods were transported to the Athens Clarke County Jail. Custody of Hunt and Woods was transferred to Clarke County Sheriffs deputies. Written witness statements were provided by [REDACTED] and [REDACTED]
