I responded to a report of a burglary at the [REDACTED] fraternity house. I met with the caller and several of the members. Most if the victims were not on scene, but were contacted by phone and verified they did not take property home for the holidays. [REDACTED] had reported the burglary and walked me through the scene.

There back porch of the building had a small alcove that had an unlocked door that opened to a set of stairs. These stairs led to a locked door that had been kicked open.

From there the burglar(s) entered the rest of the rooms in the house. Some doors were forced open and others were not.

In the room [REDACTED] occupied by [REDACTED] the door was not damaged, but an Xbox was missing. In the room occupied by [REDACTED] an Xbox was missing. In the room occupied [REDACTED] the Xbox was removed from it's location but not stolen. In the room occupied by [REDACTED] an Xbox was stolen. The door was undamaged. The room occupied by [REDACTED] had an Xbox stolen.

Three other interior doors were damaged, but at the moment nothing was obviously stolen from those rooms. There were a total of seven damaged doors including the exterior door.

There were no suspects, no serial numbers available at the time of the report and there will likely be other items reported stolen once the residents return and inspect the rooms personally. At this time only X Boxes were stolen. nothing else of value seemed missing

I gave the members there a case number.
