## Notes/Narratives

### NARRATIVE

On 091412 at approximately 0310 hours I was on routine patrol when I was dispatched to Russell Hall in reference to an intoxicated subject. Upon arrival I met with housing security who advised me that there was a female partially conscious in room [REDACTED]. Housing security advised me that the individual was a resident of Brumby Hall and that no one had claimed her as a guest in Russell. I went to room [REDACTED] and observed a female, later identified as Paden Janney, lying on the bottom bed. I asked her to speak with me and she sat up and said "ok". While sitting in the bed she had a slight side to side sway and I noticed the moderate odor commonly associated with an alcoholic beverage coming from her person. I asked Janney how much alcohol she had consumed she mumbled "not that much". A check of her name and date of birth through GCIC revealed that she was under the age of 21. At this point Roman Stadnitskiy came over from room [REDACTED] and asked what was going on. I immediately noticed the moderate odor commonly associated with an alcoholic beverage coming from his breath. I then asked Stadnitskiy if he had been with Janney earlier in the evening and he stated "yes". I asked him what they had been doing and he stated "they went out and walked down the street". A resident assistant asked Stadnitskiy if Janney was his guest and he said "yes". The resident assistant then explained to Stadnitskiy that he was responsible for his guest and they needed to stay with him at all times. I then asked Stadnitskiy how much alcohol he had consumed and he said a little more than her and pointed towards Janney. I asked Stadnitskiy what they had been drinking and he said "just a little rum". I had dispatch run a GCIC check of Stadnitskiy's OLN which revealed that he was also under the age of 21. I asked Janney if she needed EMS to come and check her out and she stated "no". I placed both individuals under arrest at 0326 hours for Underage Possession of Alcohol 3-3-23. I searched Stadnitskiy incident to arrest and no contraband was found. Officer J. Davis searched Janney incident to arrest in the presence of a female resident advisor and located no contraband. Both individuals were transported to the Clarke County Jail and issued one citation each (#034072) (#034071) for Underage Possession of Alcohol 3-3-23. There is a MVR recording of the transport. After transport I was notified by dispatch that a resident advisor had located Janney's phone. Janney advised me at scene that she did not have a phone on scene I retrieved the phone and put it into evidence locker # 18 to be returned to Janney.
