Notes/Narratives

NARRATIVE

On 02/26/14 SPO Walker and I were riding as a two person unit in the area of Cone Dr. As we approached the area of 125 Cone Dr. I observed a vehicle fully engulfed in flames. The vehicle (a 2002 Chevy Impala with tag number PBX7541) was parked on the property of 125 Cone Dr. I also observed a black male running from the vehicle. The black male's leg was on fire and he was carrying a gas can that was also on fire. The male then threw the gas can down onto the street and rolled around in a grassy area to put out the flames on his leg. I observed that the male was wearing all black clothing including black gloves and a black knit hat. The male was running toward a white Honda Accord that was parked on Cone Dr. The white Honda Accord was running and the front, driver's side door was open.

Contact was made with the male and he was identified as [REDACTED]. [REDACTED] stated that he was driving past and saw the car on fire. [REDACTED] stated that he ran to the car to see if anybody was inside. EMS responded and took [REDACTED] to ARMC. CID and Forensics were notified and both responded to the scene.

[REDACTED] vehicle (a 2004 Honda Accord with tag number [REDACTED]) was towed by Dennis and Judy's Towing and a hold was placed on the vehicle for evidentiary purposes.

I spoke with a representative of CCFD and I was advised that he would be contacting their arson investigator.

I checked the area where [REDACTED] was seen running and located [REDACTED] cell phone. The cell phone was placed into evidence.
