At 1458 hours on 03/06/2014 I was dispatched to Brumby Hall in reference to a stolen bicycle. Upon arrival I met with [REDACTED] who stated that just prior to calling he had noticed his bicycle missing. [REDACTED] stated that he had parked his bicycle in the bike rack between Brumby Hall and the Brumby parking lot after he had a wreck on it before the snow days which began February 11th 2014. [REDACTED] stated that the bicycle has a bike lock with it but as a result of the stress from wrecking he believes that he forgot to affix the bike to the rack, and that the lock was left coiled around the frame.

[REDACTED] stated that his bicycle is a grey SE Racing bike (\$400.00) with black spokes in the tires. The grey paint is a flat/matte finish and has the work "Tripel" painted on the frame in blue paint. He stated that he had upgraded the handlebars with black riser bars (\$20.00). Newton stated that the bike appears to be fixed gear but has a cover over the gear system. There should be slight damage to the right side of the seat and riser bars from his accident in February. He stated that his bike lock should be with the bicycle (\$36.00).

[REDACTED] did not have the paperwork containing the serial number. He stated that the bicycle was purchased at the Sunshine Cycles in Watkinsville in June of 2013. I contacted Sunshine Cycles to obtain the serial number but have not received a response.

This incident had a total loss value of \$456.00.

[REDACTED] was issued a Case Reference Card.

No GCIC entries have been made at the time of this report due to a lack of a serial number.

I arrived on scene and made contact with victim number one Ibukunoluwa [REDACTED] (GA: 056008309) who stated that an unknown individual cut the lock of his bicycle and took his bike with the intention of depriving him of his property.
