COUNT VI: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do further charge and accuse LUCAS RAPOSO, ANDRE RUFF and CORMAINE GOSS with the offense of CONSPIRACY TO POSSESS WITH INTENT TO DISTRIBUTE, DISTIBUTE AND SELL MARIJUANA for that the said LUCAS RAPOSO, ANDRE RUFF and CORMAINE GOSS on the 13th day of January, 2015, in the County aforesaid, did unlawfully conspire with each other to possess with intent to distribute, distribute and sell marijuana; in violation of O.C.G.A §§ 16-13-30(j) and 16-13-33; Contrary to the laws of said State.

COUNT VII: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse LUCAS RAPOSO, ANDRE RUFF and CORMAINE GOSS with the offense of POSSESSION OF FIREARM DURING COMMISSION OF A CRIME for that the said LUCAS RAPOSO, ANDRE RUFF and CORMAINE GOSS on the 13th day of January, 2015, in the County aforesaid, did unlawfully have on and within arm's reach of said accused's person, a firearm, to-wit: a certain handgun, during the commission of a felony crime involving the distribution, sale and possession with intent to distribute marijuana; in violation of O.C.G.A §§ 16-11-106(b); Contrary to the laws of said State.

COUNT VIII: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do further charge and accuse ANDRE RUFF and CORMAINE GOSS with the offense of ARMED ROBBERY for that the said ANDRE RUFF and CORMAINE GOSS on the 13th day of January, 2015, in the County aforesaid, did unlawfully and with intent to commit theft, take marijuana, property in the possession of Min Seok Cho, from the person and immediate presence of Min Seok Cho by use of an offensive weapon, to wit: a certain handgun; in violation of O.C.G.A § 16-8-41; Contrary to the laws of said State.

COUNT IX: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do further charge and accuse ANDRE RUFF and CORMAINE GOSS with the offense of AGGRAVATED ASSAULT for that the said ANDRE RUFF and CORMAINE GOSS on the 13th day of January, 2015, in the County aforesaid, did unlawfully make an assault upon the person of Min Seok Cho with a certain handgun, a deadly weapon, by shooting him with said handgun; in violation of O.C.G.A § 16-5-21; Contrary to the laws of said State.

COUNT X: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do further charge and accuse ANDRE RUFF with the offense of POSSESSION OF FIREARM DURING COMMISSION OF A CRIME for that the said ANDRE RUFF on the 13th day of January, 2015, in the County aforesaid, did unlawfully have on and within arm's reach of his person, a firearm, to-wit: a certain handgun, during the commission of at least one of the felony offenses set forth in Counts III, IV, V, VIII and IX of this Indictment, said offenses being against and involving the person of Min Seok Cho; in violation of O.C.G.A § 16-11-106; Contrary to the laws of said State.

COUNT XI: And, We the Grand Jurors aforesaid, in the name and on behalf of the citizens of the State of Georgia, do further charge and accuse CORMAINE GOSS with the offense of POSSESSION OF FIREARM DURING COMMISSION OF A CRIME for that the said CORMAINE GOSS on the 13th day of January, 2015, in the County aforesaid, did unlawfully have on and within arm's reach of his person, a firearm, to-wit: a certain handgun, during the commission of at least one of the felony offenses set forth in Counts III, IV, V, VIII and IX of this Indictment, said offenses being against and involving the person of Min Seok Cho; in violation of O.C.G.A § 16-11-106;

Contrary to the laws of said State, the good order, peace and dignity thereof.
