NARRATIVE

On March 26, 2012, the University of Georgia Police Department received a complaint of simple assault forwarded from the Office of Student Conduct. The victim reported, via e-mail, to the Office of Student Conduct that she had been confronted and threatened by two individuals known to her outside Joe Brown Hall on March 23, 2012 at around 1530 hours. The victim advised that she felt in fear of receiving a physical assault during the confrontation. The confrontation between the parties stemmed from an earlier complaint that the victim had filed with the Office of Student Conduct regarding an organization in which she had been previously involved.
