NARRATIVE

On 10/09/13 at 1659 hours while on patrol Officer Hickey and I were driving down Cloverhurst Avenue by Peoples Park with our windows down when we noticed the strong odor of burning marijuana. With prior knowledge of the illegal drug activities that have taken place inside of Peoples Park we turned around and approached the park on foot. Upon entering the park the odor dissipated leading us to believe that the odor was coming from a well-worn trail that leads to areas used by individuals to smoke and use illegal substances. Officer Hickey and I started up the trail. Upon reaching a steep incline we could view individuals sitting in chairs and smoke coming from the area. Officer Hickey and I then approached and noticed the strong odor of burning marijuana in the area. Upon approaching we encountered five males sitting around a lawn table in lawn chairs.

When we looked on the table we could view a small plastic baggie containing suspected marijuana, a purple glass pipe, a wooden grinder, a black lighter wrapped in twine, a red lighter, and a green metal grinder. There was also a set of keys on a UGA lanyard on the table. When asked what was going on the males did not reply but simply stared at us. One of the males, David Feldman, dropped a pill bottle on the ground in an attempt to conceal it under his chair. I then moved and asked Feldman to see the pill bottle and he produced it. Upon checking the pill bottle I noticed it had Feldman's name on it and contained a plastic baggie which is consistent with someone who is using a pill bottle to hide marijuana. I asked Feldman if it was his and he shook his head in an up and down motion indicating that it was his. I then opened it and discovered a plastic baggie with suspected marijuana. When looking at the males eyes I noticed that all had blood shot eyes. The males were then asked again what was going on and again they had no answer. The males were asked if the items were theirs and they sat in silence. They were asked a second time and no one answered again. The entire area where the males were seated smelled of burnt marijuana. I then called for another unit. Officer Storey and Officer Murphy arrived on scene. I then identified all five individuals they are as follows, Karan Patel, David Feldman, Nathanael Sims, Jacob Suggs, and Sebastian Holt.

Upon checking the area a pack of Zig Zag Rolling Papers was found behind Nathanael Sims. Nathanael Sims stated that he dropped the rolling papers. Officer Storey checked the woods within throwing distance of the group and located a freshly burnt marijuana cigarette. I noticed a broken red glass pipe lying on the ground between Feldman and Patel. The individuals stated that the red pipe was already in the area when they arrived. The decision was then made that because of the way the individuals had set up the area with all five surrounding the table with the contraband and that all individuals had blood shot eyes and were behaving in a manner consistent with someone that had recently smoked marijuana, slow to react and not having a clear train of thought, that all would be placed under arrest. The decision was also made because all individuals would have had to have possessed the marijuana to have

consumed it and no one was coming forth with information as to who had possessed the marijuana.

Due to the terrain it would have been unsafe to handcuff the five individuals at the location we encountered them. We then escorted all five individuals down the hill to the platform in Peoples Park to conduct the search incident to arrest and handcuffing. Officer Storey stayed at the location where we encountered the five males and secured all evidence.

In the area where the individuals were located a set of keys on a lanyard were found. None of the individuals claimed the keys and stated they were already there when they got there. Attempts were made to contact the Key Shop to find out the owner of the keys but they were already gone for the day. They stated they could let us know who they belong to the following morning.

Upon arriving at the platform we, Officer Murphy, Officer Hickey, and I, then handcuffed the five individuals behind the back in double locking handcuffs and searched them incident to arrest. No contraband was found on their persons. The evidence was then secured in bags along with their belongings. While securing the items Feldman stated the green grinder, black lighter wrapped in twine, purple pipe, and pill bottle with suspected marijuana were his. Sims stated that the wooden grinder, rolling papers, and marijuana were his. None of the individuals took ownership of the broken red glass pipe, red lighter, burnt marijuana cigarette, or an empty white pill bottle that had the odor of green marijuana coming from within the container.

All individuals were then escorted to the street and Corporal Humphries was called to assist in transporting the individuals. While waiting on Corporal Humphries to arrive the individuals asked us how this was going to affect their school. We informed them that that was up to student conduct. Two of the individuals asked what their punishment was going to be because they had already been arrested earlier this year for possession of marijuana. I told them I did not know. The individuals that asked were Jacob Suggs and Karan Patel.

Upon Corporal Humphries arrival we divided the individuals up and transported all five back to the University of Georgia Police Department to complete paperwork. Officer Humphries transported Feldman to the University of Georgia Police Department. Officer Murphy and Officer Storey transported Suggs and Holt to the University of Georgia Police Department. Officer Hickey and I transported Patel and Sims to the University of Georgia Police Department. Upon arrival Officer Murphy and Corporal Humphries went back in service while Officer Storey, Officer Hickey, and I completed the paper work for the booking process. Officer Storey filled out the citations which I signed. I filled out the Arrest Booking Reports for all five individuals. All five individuals were charged with misdemeanor possession of marijuana and issued citations. The individuals were then transported in two groups of two by Officer Storey and Officer Hickey. Officer Storey transported Feldman and

Suggs. Officer Hickey transported Sims and Patel. I transported Holt upon completion of the paper work.

All individuals were issued citations and turned over to the deputies on duty at the Clarke County Jail.

The incident was recorded on my Flex Camera.
