On April 17, 2014 at 0046 hours I responded to Sanford Stadium in reference to an intrusion alarm. Upon my arrival I made my way into the stadium from the loading dock located on East Campus Road. Once inside the stadium I was coming out of the tunnel when I observed several white males and females standing together all wearing dark colored athletic clothing. The individuals made eye contact with me and I with them. The individuals then began to run up the stairs toward the 200 level. I began to follow the individuals but lost sight near the 200 level. I made my way toward Gate 8 and could see the individuals running behind the Physics building near Field Street. I radioed the location of the individuals so that other units could set up a perimeter.

Officer Haas advised he had contact with two females in dark athletic attire near the Biology Building and SPO Hamsley advised she had contact with seven individuals wearing dark athletic attire near the Chemistry Building. I made my way to Officer Haas' location and made contact with the two females Leslie Stapley and Rachel Paleg. Stapley and Paleg both appeared to be out of breath and were fanning themselves as I approached. Stapley and Paleg even pointed at me and smiled as if they had recognized me. Stapley and Paleg both admitted to being inside Sanford Stadium and gained access through Gate 8 which was secured with a chain and lock but was ajar enough for them to slide through. When I asked Stapley and Paleg why they did not stop when I asked them to, they stated they did not notice I was the police and thought I was turf management.

SPO Hamsley advised me the individuals she was with were denying being inside the stadium. Stapley and Paleg agreed if they saw the others they could identify if they were in the stadium. I assisted SPO Hamsley with escorting the group to Officer Haas' location. Once there, Stapley and Paleg stated that was the group they were with inside the stadium. I questioned the group again about being inside the stadium and all continued to deny it. I noticed one individual, Jamie Gottlieb, take a large sigh and look away from the rest of the group. I asked Gottlieb to step away from the group and talk separately with me. While questioning Gottlieb she was worried what she would be facing. I advised Gottlieb if she was inside the stadium she would be facing a 60 day barring from that location. Gottlieb then admitted to being inside the stadium with the other individuals.

I returned to the group and asked again if they were inside the stadium and that I knew they were because Gottlieb just stated they were. Tucker Green then asked me if he was being detained. I stated he was being detained pending the investigation. Green then stated on what grounds was he being detained. I advised Green that he matched the description of individuals that I chased inside the stadium. The group continued to remain silent. I then told the group that Gottlieb was honest with me and is now taking care of her paper work and will soon be going home. Two individuals at the end of

the group, Shaun Klerer and Elizabeth Ridgeway, got up and stated they were in the stadium. Klerer and Ridgeway made their way to Officer Haas to provide their information to him.

Green still remained seated on the curb and acted as if he wasn't inside the stadium. Shortly after Klerer and Ridgeway admitted to being in the stadium the others, with the exception of Green, began to get up and admit to being in the stadium. Once Green was the only one left on the curb he finally got up and stated he was sorry and stated he was inside the stadium.

Colton Houseman, Rachel Paleg, Tucker Green, Marshal Mosher, Leslie Stapley, Sarah Walls, Elizabeth Ridgeway, Shaun Klerer, and Jamie Gottlieb were all issued a barring notice from Sanford Stadium for a period of 60 days from the date of this report. Each individual received a copy of the barring notice. No photographs were taken.

Due to no damage being discovered inside the stadium, this charge of Criminal Trespass will not be pursued, and this case is exceptionally cleared.

Supplement Notes

This information is intended to be part of the original report.

On 041714 at 1245 hours I was dispatched to an intrusion alarm at Sanford Stadium. While I was en route Officer Robinson stated he was on scene on the East Campus Road side of the stadium, and I went to back him up. Ofc. Robinson then advised he observed a large group of people walking off the field and toward his location. When the group saw Ofc. Robinson, they began to run from him to the south side of the stadium toward Field Street. He identified them as a group of males and females, some of which were wearing black sweaters and sweatpants. I went to Field Street to attempt to intercept the group when Ofc. Robinson advised they had exited the stadium and were traveling toward Cedar Street near the Physics Building. I then went to Cedar Street, where I witnessed a large group of seven individuals traveling eastbound on Cedar Street. I parked and exited my vehicle to approach the group, and Ofc. Francis arrived as well.

Ofc. Francis spoke with a large portion of the group, which consisted of four males and a female. Two females were standing away from the others, and I approached them. They identified themselves as Jamie (Jamie Gottlieb) and Sarah (Sarah Walls) and stated they were a part of a "capture the flag" group that had been active in the area. Both individuals were out of breath while I spoke with them, and sweat was visible on both of their faces. I asked if they had been inside the stadium, and they denied being there. I explained why they had been stopped and inquired more about the game they were playing. Neither was able to provide specific answers to any of my questions regarding the subject, and Jamie continually expressed discomfort with being questioned by police.

Ofc. Robinson arrived on scene, and he and I escorted them to the front of the Biology Building, where Ofc. Haas had stopped two other individuals related to this incident. Several of the individuals questioned why they had been stopped and continued to evade the question of whether or not they had been inside the stadium. After learning that the two individuals Ofc. Haas was speaking to had not only already admitted to being in the stadium but that the group had also been with them, they all admitted to being there. All of the individuals were issued barring noticed stating they were barred from the stadium for a period of 60 days. All received copies of the barring notices.
