**NARRATIVE**

On 8-7-13 I responded to a report of an entering auto at 120 Village Way. I met with [REDACTED] who showed me his GMC Envoy [REDACTED] Parked on the street in front of this address. The driver's side door was open and driver's side window was shattered out, leaving glass on the street and in both front seats. A baseball sized piece of concrete was found just inside the door frame of the vehicle, laying on the floor next to the seat.

[REDACTED] told me he had left with some of his friends just after midnight to go to the gas station, and were only gone for about 30 minutes. When they returned, he found the open door and broken window. The only item missing from the vehicle was a 120 GB iPod classic, black in color. This had been sitting in the driver's side cup holder in the center console. No other items were taken from the vehicle.

There were no surfaces to process for fingerprints as the outside of the car was still slightly wet from recent rain and the only thing that seemed to be touched inside was the stolen iPod. I also noticed a dent on the window frame just below the glass where it appears the thief hit the door with the concrete either before or in the process of breaking the glass.

I gave [REDACTED] a case number and told him to call if he was able to locate the serial number for the iPod. We were unable to locate any witnesses and told Tharpe to let us know if he talked to anybody in the area who saw anything.

I drove through the surrounding streets for any signs of other entering autos and found nothing.

NARRATIVE

On this date and time I responded to [redacted] for a theft call. I arrived on scene and spoke with [redacted] who advised me that sometime between 1 and 3 am this morning someone had stolen his Panasonic Viera 42" Flat Screen TV and his Sony PlayStation 3 and two controllers from his apartment that had been left unlocked. He advised that he was hanging out with a lot of people that he had just meet and some of them had been inside his apartment with him at some point in the night. He advised that he was also hanging out at some girl's apartments who he had just met as well. [redacted] stated that around 3am he noticed his stuff missing and thought it was some of the guys who had been in his apartment. [redacted] said he did not call the police because he did not want to get anyone in trouble and thought that he could just get his stuff back. [redacted] also advised that he did not know any of the names of the guys he was hanging out with but a girl from 157 did.

I went to [redacted] and spoke with [redacted] who advised that there were a lot of different people hanging out and she did not really know [redacted] but for some reason he came in the apartment with someone and would not leave. [redacted] stated that one of her friends named [redacted] had talked with [redacted] some throughout the night and she believes she remembers [redacted] saying something about some suspicious people around [redacted] apartment. [redacted] also said that [redacted] came to the apartment banging on the door asking who had stolen his stuff. [redacted] advised that she did not have any idea who would have done it.

I was able to speak with [redacted] by phone and he advised that he had seen and talked with [redacted] some throughout the night. He stated that there was a large group of people hanging out all over Polo Club and he did see some guys who he said were "up to no good" but could not give a good description. He said that [redacted] did call him and asked him about his stuff but he stated that he did not have any idea about it missing.

I quickly gave [redacted] a case number because he was in a hurry to get to his fraternity meeting.

No prints were obtained at the scene.

**Notes/Narratives**

**NARRATIVE**

On August 13th, 2013 at about 2028 I responded to the area of the dead end of East Carver drive to the report of a juvenile that was shooting a "bb gun" at children. When I arrived I spoke with the residents of [REDACTED]. Two of the adults were identified as [REDACTED] and [REDACTED]. They explained that they had left the community center on [REDACTED] and were driving all of the children listed as victims to the cul-de-sac of [REDACTED]. They both stated that as they drove away from the community center, a teenager was standing by the side of the roadway and began firing a "bb gun" at the two vehicles that were filled with children. [REDACTED] said that he stopped his truck and told the kid with the "bb gun" that if he didnt stop what he was doing he was going to come and take his bb gun. They stated that the two vehicles then went to the dead end of [REDACTED] and a short time later another adult arrived. The adult was [REDACTED] and she began yelling at [REDACTED] about threatening her son. Based on a statement from [REDACTED] the three adults were able to come to some sort of agreement and parted ways. Then, one of the childrens mother, [REDACTED] came outside because her daughter had told her about what had happened. [REDACTED] informed me that she wanted this incident reported because of the other child shooting a "bb gun" at cars.

I spoke with all of the children indiviually and they all identified the kid with the airsoft rifle as [REDACTED] and as living at [REDACTED]. Officers responded to [REDACTED] and no airsoft or bb gun was found at this residence.
