Notes/Narratives

NARRATIVE

Officer responded to a residential burglary at [REDACTED] I met with [REDACTED] He told me that overnight someone crawled into an unsecure window on the side of the residence, came upstairs to his room, and stole \$175.00 cash which was sitting on his desk. He told me that he was asleep in his bed all night in the room where the money was stolen. He said he did not hear anything. He also told me that his roommates were all inside the residence asleep during the incident. He said that all the doors and windows were locked, with the exception of the window on the side of the house which was the point of entry. He said this window does not have a lock on it so it cannot be locked. He said the person who did this must be someone he knows and he suspects a friend of his named [REDACTED] He said [REDACTED] could have easily fit through the window to get into the house. He said that when he woke up this morning, he discovered that [REDACTED] had sent him a text message early this morning at 3:15 a.m. asking him if he was up. The text was sent to the victim from [REDACTED]'s mom's cellphone. The number is [REDACTED] Another reason he suspects [REDACTED] is because there was a recent burglary at the victim's friend's house at [REDACTED] He said [REDACTED] is also friends with that victim. He said that there was a bloody shirt from that burglary from where the suspect had been cut, and that the shirt had been collected by the police and entered as evidence. He said after that burglary, he noticed that [REDACTED] had a cut on his right hand. Under all of these circumstances, the victim now believes that [REDACTED] committed both burglaries. I processed the window for fingerprints but none were found.
