**NARRATIVE**

On 041213 I was dispatched to a call of possible vandalism. Two witnesses, [REDACTED] had seen two individuals knocking on mailboxes and breaking things. These men live at [REDACTED] The individuals were described as being a male, wearing a hat, plaid shirt and dark pants and a female, wearing a possible tank top, a skirt and having curly hair. The witnesses had seen them throwing items from yards into the street. They also saw the male rip a mailbox off its post at [REDACTED] and throw it into their yard.

I caught up with two individuals matching the suspect description, at the corner of W Hancock and Franklin St. I could easily detect the odor of an alcoholic beverage coming from the breath of each individual as I spoke with them. Both individuals stated that they did not have an ID with them. The male identified himself as Sean Andrews. He gave a date of birth that showed him to be 20 years of age. The female had a full cloth purse but insisted that she did not have any ID in it. I asked if Officer Waindle could check the purse and she agreed. Inside Officer Waindle found three ID's. One was for the female; she was identified as Hillary Durr, also underage. She also had drivers licenses belonging to [REDACTED]. It has been my experience that underage people will share a license that can be used as a fake ID. These are often referred to as a "pass-along". A person uses it and passes it to the next person. Ms. Durr had no idea who those people were or how their property came to be in her purse. She agreed to blow into an Alco-Sensor, which registered a positive indication at .129. She was placed under arrest for Underage possession/consumption of alcohol and Theft of Lost or mislaid property.

I turned to Mr. Andrews and placed him under arrest, initially for Underage possession/consumption of alcohol. I started to search him incident to arrest, and started at the top in his front. His plaid shirt had a pocket on the left side. As I reached for the pocket he turned his left shoulder to the right, screening his front pocket. I turned him around and checked the pocket. Inside I found a small pink bag of white powdery substance. From my training and experience I believed that this substance was cocaine. A test with a cocaine wipe showed positive (turned blue) for cocaine. Also in the pocket was a \$5.00 bill rolled into a tight roll and a plastic hotel key card. The card would be an effective tool for distributing cocaine for immediate consumption as well as a good platform for snorting the cocaine, which the bill would be used for. In his front right pants pocket was a drivers license belonging to [REDACTED]. Mr. Andrews claimed not to know anything about it. I informed him that he would also be charged with Theft of lost or mislaid property.

On the way to the jail I met with the witnesses. They showed me the damage and I photographed the mailbox and the post. Officer Waindle transported Ms. Durr and I took Mr. Andrews. They were taken to the ACC Jail. Both were issued citations for the Underage charge. I will secure warrants for
