Upon arrival, I met with [REDACTED] [REDACTED] had already left the scene. [REDACTED] stated that [REDACTED] and her got into a verbal argument about how they were going to spend the day. The argument escalated to a point where [REDACTED] threw a glass of water on [REDACTED]. [REDACTED] then jumped on [REDACTED]. The two struggled briefly until [REDACTED] pushed [REDACTED] to the floor. [REDACTED] got up and [REDACTED] held [REDACTED] against the wall with his hands around her throat. [REDACTED] got loose and fled to her bedroom and locked the bedroom door. [REDACTED] then kicked the bedroom door in and continued to yell at [REDACTED] without further physical violence. [REDACTED] then left the apartment.

There is no DV relationship between [REDACTED] and [REDACTED] does not want to pursue criminal charges at this time but wanted the incident documented in a report. [REDACTED] declined EMS and she had no visible injuries. I did observe the bedroom door was damaged.

I provided the case number to [REDACTED] and advised her on pre-warrant procedures.

I returned to service.

On 2-9-2013 at 0240 I met with [REDACTED] outside Little Italy. She said that she was walking with friends from Max Canada to Little Italy when they noticed an older male following them. She said that when they got to Little Italy the male asked her how to get the Holiday Inn. She said that she walked with him down to Broad to point out the Holiday Inn. She said that when they got to the corner he grabbed her and pulled her to him and tried to kiss her. She said that she pushed away and said no. She said that he then pulled her back again and tried to kiss her again. She said that she then pushed away and ran back to Little Italy. She said that the male grabbed her like he was hugging her. [REDACTED] could only say that the male was 45 to 55 years old and had gray hair. I also spoke to [REDACTED] roommate [REDACTED] who had a better look at the male. She said that he had on a black jacket and blue jeans. She said that she would recognize him if she saw him again.
