**NARRATIVE**

On 09/22/2013 at approximately 0328 hours, while on patrol in a marked UGA police vehicle, UGA dispatch received a call in reference to an armed robbery that had just occurred near Lumpkin Street.

I met with the victim in the Sigma Chi parking lot behind the Sigma Chi house, who stated that he was offered a ride home by three unknown black males in exchange for money, while he was walking downtown. The victim stated that after accepting a ride to the Sigma Chi fraternity house the three unknown black males robbed him at gunpoint before he exited the vehicle while in the roadway of Lumpkin Street in front of the Sigma Chi fraternity house.

The victim stated that the three unknown black males were approximately 5'10" to 6' in height with slim/lean builds. The driver was further described as having dread locks approximately to his shoulders and wearing a white t-shirt. The front seat passenger (who produced the handgun) was further described as having shoulder length dread locks and wearing a dark navy or black t-shirt. The rear seat passenger was further described as having a short afro type hair style.

The victim's brown leather two fold wallet with a flap for his license inside (\$20) and his iPhone 4S (\$300) were stolen. The wallet contained \$5 in US currency, 1 Georgia driver license issued to the victim (\$1), 1 University of North Georgia student id (\$1), 1 Wells Fargo debit card (\$1), and 1 health insurance card (\$1). Total loss to the victim was \$329 at the time of theft.

The victim completed a written witness statement after being transported to the UGA police department.
