Notes/Narratives

NARRATIVE

On 09/07/2013 at 0845 hours dispatch received a notification from Security Central of a fire alarm activation at Sanford Stadium in the Reed Plaza Area. Officer Truax arrived on scene at 0847 hours and began to foot patrol Reed Plaza. Officer Truax observed smoke billowing out of the overhead rollup doors on the north side concession stands. [REDACTED] unlocked the concession stands door for Officer Truax to gain entry. CCFD arrived at 0857 hours and extinguished the fire and cleared the smoke from the area. I arrived at approximately 0925 hours. The fire caused damage to a Dippin` Dots machine, a large stainless steel table/freezer, electrical outlet, a folding chair and smoke damage/stains to the floor, wall, and ceiling. CCFD personnel stated the fire appeared to be caused by a faulty power cord or possibly that the Dippin` Dots machine needed a heavier guage power cord than the one that was being used. The Dippin` Dots machine and power cord were taken into evidence and place in the evidence shed. [REDACTED] arrived and reset the alarm at 0940 hours. Photos were taken. This incident was recorded on my Axon Flex camera.
