Notes/Narratives**NARRATIVE**

On 02/03/2013 at approximately 0025 hours, I was on patrol. I arrived at the intersection of N. Jackson St and E. Washington St. to find an unknown individual staggered into the street in front of a moving vehicle. I put my patrol vehicle in park, activated my emergency lights and exited my vehicle. I grabbed the individual and moved him to the sidewalk. I immediately smelled an odor associated with alcoholic beverages coming from his breath and person. I asked the individual what he was doing and he stated that he was trying to keep his girlfriend out of trouble. There was no female with him. I asked the individual his name and he stated Joseph Basila. I asked Basila for his identification card and he gave me a Georgia driver's license and a [REDACTED] driver's license. A GCIC check revealed that the Georgia driver's license belonged to Joseph Henry Basila and he was 20 years of age. A GCIC check of the [REDACTED] driver's license revealed that it was fraudulent. It came back driver not on file. The name of the driver on the license was [REDACTED]. The fraudulent driver's license was placed in evidence locker [REDACTED].

At approximately 0028 hours, I placed Joseph Henry Basila under arrest. I placed Basila in double locked handcuffs behind his back and search him incident to arrest. No contraband found. I placed Basila in the backseat of my patrol vehicle and seatbelted him in. I began transport to the Clarke County Jail at approximately 0033 hours. I arrived at the jail at approximately 0040 hours. Basila was transferred to deputies for processing. Basila was charged with O.C.G.A 16-9-4 Possession of a Fraudulent Identification and O.C.G.A 3-3-23 Underage Possession of Alcohol Consumption.

I searched the backseat of my patrol vehicle before shift and before and after transport. No contraband found. My MVR did not active due to the data card being full. I recorded the transport via my personal portable recording device.

At approximately 0647 hours, I met with Athens Clarke County Magistrate Court Judge Pomerene via video conference in reference to arrest warrants on Joseph Henry Basila for O.C.G.A 16-9-4 Fake ID Possession and O.C.G.A 3-3-23 Underage Possession of Alcohol Consumption. At approximately 0700 hours, Judge Pomerene signed all arrest warrants on Basila using the Electronic Warrant Interface system.
