NARRATIVE

On 01052014 at approximately 0320 hours, I was dispatched to [REDACTED] in reference to a crying female claiming she had been robbed downtown Athens.

Upon my arrival I met with the Victim ([REDACTED]). [REDACTED] stated she had been at Jerzee's Sports bar drinking with friends. She said she met a male at Jerzee's who said he was a freshman at UGA and lived in [REDACTED]. She could not remember any descriptors about the male other than he had dark brown hair. [REDACTED] advised me that the male wanted her to go back to his place with him. [REDACTED] said she trusted him, and decided she would go with him.

[REDACTED] said they walked through campus, past the UGA Chapel, down Sanford Dr., and ended up by the Tate Center bus stop. She said while at the bus stop, the male received a phone call from another female. She said it sounded like the male was really interested in the female he was on the phone with, and because of this, she decided that she wanted to get away from him. She said she began to walk away and the male "got handsy" and grabbed her arm. She said she continued to try to get away from him, and then the next thing she remembered was being at [REDACTED]

[REDACTED] reported her iPhone 4s (\$100.00), pink Vera Wang wallet (\$20.00), Driver's License (\$1.00), and sixty dollars cash missing. She believed that the unknown male had taken it from her. The total stolen amount is \$181.00.

The on-call Detectives were notified of the incident. Upon their arrival, the incident was turned over to Det. Lt. Hammock and Det. Cpl. Lavender for further investigation.
