NARRATIVE

On April 23, 2013 at 1208 hours, I was dispatched to the Day Chapel at the State Botanical Gardens owned by the University of Georgia in reference to ongoing harassment. The University of Georgia Police dispatch received information from a third party Kenneth Buckner advising one of his employees was currently getting harassed by an ex-boyfriend at the Day Chapel. I arrived on scene and the supposed suspect was gone from the scene upon my arrival. I met with the victim [REDACTED]

[REDACTED] and she stated her ex-boyfriend whom had been residing with her since February 2013, showed up at her work with the intent to harass and intimidate her after she told him on yesterday's date she did not want to have any contact with him. Calhoun advised the suspect arrived at her work at about 1150 hours and left a few minutes prior to my arrival. The victim advised she wants to press charges against the individual and have him barred from her place of work.

The victim was given a case reference card and given a brochure about the Clarke County VINE services.

My MVR was activated for this incident.



NARRATIVE

On this day, 04/23/13, I was dispatched to [REDACTED] in reference to an entering auto that had occurred some time over the night. When I arrived, I made contact with the caller, identified as [REDACTED]

[REDACTED] advised that he had parked his car at this location in the driveway at approximately 0001hrs this day. [REDACTED] advised that when he had gone to his car at about 1000hrs, he found that several items were missing from his car. [REDACTED] advised that his iPod, an auxiliary cable, and an ashtray that had about \$15 in quarters in it, were all missing.

[REDACTED] advised that he has recently been having problems with his car's doors not locking when he presses the button on the remote control lock. [REDACTED] advised that he recalls hitting the button last night but could not advise if the door locked properly when he did so. [REDACTED] advised that he found no damage to his car, a [REDACTED]

[REDACTED] advised that the iPod (a black 160GB iPod Classic) had been sitting on the passenger seat with an attached lime green auxiliary cable. [REDACTED] advised that at this time he does not have the serial number for the iPod but was advised to call PD when he does find it so the item can be entered into GCIC.

I dusted the door and windows of [REDACTED] car but there were no usable prints, only smudged finger marks. There did not appear to be any surfaces on the inside of the car that had been disturbed.

[REDACTED] advised nothing appeared to have been opened or disturbed and that he had used the car all day before calling PD to report the items taken.
