Notes/Narratives**NARRATIVE**

On this date I was dispatched to Lumpkin Street near Dougherty for what was initially reported as a battery. I arrived and met with [REDACTED] and [REDACTED]. Detective Patterson had been contacted prior to my arrival and I was told he was in route. Both victims admitted to being intoxicated and appeared to be intoxicated to the point they had difficulty walking a straight line. They both stated that they had been downtown and a friend of theirs got arrested earlier. Since then they had been walking around making phone calls to figure out how to assist their friend. When they were walking on Lumpkin near the side entrance to Bethel Midtown Village, they were grabbed by two Black males and drug into an "alley", where the subjects beat them and took money from both and a cellphone from [REDACTED]. [REDACTED] advised one of the subjects choked him to the point that he passed out and [REDACTED] had to wake him up.

Due to similar incidents in the same area occurring recently, some of which involved suspected drug transactions, I asked the victims if they had been offered drugs or asked to buy any prior to this incident. They indicated at first that they did not, then they said the suspects did say they had "coke for the low low", possibly a reference to powder cocaine. [REDACTED] and [REDACTED] said they told the males repeatedly they did not want any cocaine. At some point the males grabbed them each in headlocks and led them into an alleyway. That is when they demanded their money. The order and location of events changed several times. It is not clear whether or not the victims were ever inside Bethel Midtown Village. They described an alley, a bridge, and later possibly a breezeway.

The description I was given was that one subject wore a red UGA jersey, was approximately six foot one inches tall, thin build, and had short hair. The other subject was wearing a white wife beater style t-shirt and camouflage pants. Both suspects were Black males. The victims were interviewed by Detective Patterson. That is the extent of my involvement in this matter.
