Notes/Narratives

NARRATIVE

On 03/22/14 at 1724 hours I was dispatched to the UGA Golf Course in reference to an injured person. I arrived on scene and met with the injured party, [REDACTED]. I observed that [REDACTED] hat in his hands was covered in blood and there was a large lump on the left side of his head with blood that matted his hair. By the time I arrived it appeared that the bleeding had stopped. I spoke briefly with [REDACTED] and he stated that he was hit by a golf ball. [REDACTED] speech was slurred and he stuttered; he seemed to struggle to put together a full timeline of what had transpired. I spoke with his neighbor and golf partner [REDACTED], who stated that an individual who they had been playing with all day had teed off while he and [REDACTED] were driving away on the golf lane directly to the right of the tee. [REDACTED] stated that while [REDACTED] was driving the golf cart away from the tee he was struck on the left side of his head by a golf ball that had been hit by the individual whom they had been playing with. [REDACTED] stated that typically when someone is about to tee off, and someone is in a cart in the area they either wait or warn them; he stated that the individual did neither. [REDACTED] filled out a witness statement.

EMS arrived on scene at 1738 hours and they transported [REDACTED] to Athens Regional Medical Center (ARMC). The UGA Golf Course staff obtained the name of the individual who had been playing with [REDACTED] and [REDACTED]; I then had UGAPD dispatch contact the other involved individual via telephone and he agreed to meet me in the main Golf Course parking lot. I met with him and he identified himself as [REDACTED]. [REDACTED] stated that he had been playing with [REDACTED] and [REDACTED] for most of the day. [REDACTED] stated that he didn't ask [REDACTED] and [REDACTED] to move out of his way because they had been playing better than him. [REDACTED] stated that he was embarrassed by his play and he thought he could quickly tee off while they were driving to the next hole. [REDACTED] stated that he misjudged his swing and the ball went wide right striking [REDACTED] on the left side of his head. [REDACTED] declined to fill out a witness statement. Involved parties were given case reference number cards. At 1828 hours I arrived at ARMC to ascertain the extent of [REDACTED] injuries; however they hadn't run any tests yet. At that time I took photographs of [REDACTED] injuries.
