On Thursday morning October 3, 2013 around 0157, I responded to the area of the Lazy Shopper on E Clayton Street reference a theft. While in route, dispatch notified a female was arguing and trying to physically push her way out the door. When I arrived on scene, I had contact with two females.

As I walked into the business, the manager, [REDACTED] pointed out a tall blonde female standing near the door and stated, she is the one who stole the items and then pointed out the items that had been stolen. There were two items that totaled \$2.33. The items were returned to the store.

I spoke to the female in question and asked for her ID. I asked if she stole the items and she admitted yes, but she had returned them prior to my arrival. Speaking with [REDACTED], he told he gave her the opportunity to return the items, but she refused and got an attitude with him stating, 'I will never get caught'. The female in question was identified as Eleanor Gutermuth. Gutermuth admitted to stealing the items and placing them in her purse to conceal their identity and then tried to leave the store. The store employee stopped her at the exit and demanded the items be returned.

I watched the surveillance cameras in the store immediately following the incident and it showed Gutermuth taking the items off the shelf and concealing them in her purse.

While speaking with Gutermuth, I recognized the two as having just walked out of Flannigan's Bar. Flannigan's is a 21 and over establishment. Looking at Gutermuth's ID, it showed her being 18 years old. When I asked to see Holder's ID, she handed me a tattered license out of Ohio and I asked her if this was her real ID; she responded no. I asked for her real ID and once shown, it confirmed her being under the age of 21. I asked if they had been drinking this date and both admitted yes. They advised two shots and two drinks.

Both Holder and Gutermuth were warned by [REDACTED] of Criminal Trespass for 2 years from the Lazy Shopper.

Both ladies were placed under arrest for the listed offenses and transported to the county jail.

A video of the incident was attached to the F-Drive downtown folder under my name.

No further at this time.

[REDACTED] stated that she received a private message from [REDACTED] on Facebook. In the message [REDACTED] told her that she would "fuck her up like she did someone before".

[REDACTED] told me [REDACTED] was referring to her mother in law [REDACTED]'s boyfriend's mother, [REDACTED] (husband's mother). She had bruised several of her ribs and caused other injuries. The mother in law has received threats as well but she is afraid of [REDACTED]. The mother in law lives in Atlanta.

[REDACTED] told me that this is stemming from possible jealousy. [REDACTED] is not a favorite of the family even though she is married in to them. [REDACTED] also stated that [REDACTED] has anger issues and uses drugs. There has been threats prior to this and other fights. Family gossip started issues back up again.

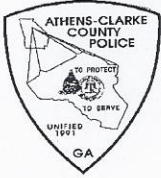

On Wednesday, October 02, 2013; 1720 hours, I was dispatched to [REDACTED] in reference to burglary, and to meet with [REDACTED] who advised the incident occurred within the last couple of hours. The residence was cleared except for the basement, and it was unknown how entry was made.

Upon my arrival, 1731 hours, I met with victim, [REDACTED] who said she left the house around 1430 hours today and returned around 1630 hours and at first did not observe anything out of place until she went to get the trash ready to be picked up and noticed that some garden tools had fallen; however, were standing upright against a storage locker under the upstairs patio. [REDACTED] said she did not think anything of it. [REDACTED] said she checked the mail, returned inside and went to the bathroom and observed her late husband's coin bags lying on the master bedroom bed. [REDACTED] said she then went to check the middle bedroom dresser where the coin bags were kept and found that some of her and her late husband's jewelry as well as a watch were missing. [REDACTED] said she then observed the Nintendo Wii missing from the top of entertainment system in the den. [REDACTED] said she might have scared the unknown person(s) who broke in, because the two bags full of coins, and the controllers to the Wii game were not taken. It was unknown how entry was made into the residence, but the victim said that the offender(s) could have made entry through the basement. [REDACTED] then showed me the interior door to the basement, the door knob was that of a regular bedroom door but with a deadbolt lock with key only. [REDACTED] said the deadbolt was unlocked but the door knob lock on the basement stairwell side was locked and could not be unlocked.

[REDACTED] said the items she observed missing were:

Men's gold Seiko watch valued at \$250.00

Men's gold nugget ring with diamond valued at \$400.00

Men's traditional gold ring, square with diamond in the middle valued at \$400.00

Women's silver topaz ring, large made to be worn on the index finger, valued at \$60.00

Women's 14k gold topaz ring in black box valued at \$75.00

Women's multi-color pearl stretch bracelet with pink, till, grey, and two regular pearl colored bracelets valued at \$50.00

Women's White Mountain leather purse, black in color, with orange tone inside valued at \$200.00

██████ said she believes the offender(s) who entered her residence were her neighbors at ██████. ██████ said that they just moved in about a month ago and they do not have a working car. ██████ said they have a son who lives in the basement and is very slim; he was also observed walking up from the woods in their backyard after she returned home. ██████ thinks he may have hidden items in the woods on their property. ██████ also said that the neighbors would be the only ones to have seen her leave and she had not left the residence since last week.

I then used one of my plastic cards and unlocked the upstairs basement door, and since the basement wasn't cleared I proceeded to clear it. Once I cleared the basement I observed that the exterior basement door deadbolt was unlocked, but the door knob was locked. I exited the basement and checked the exterior door for pry markings finding none. I returned to ██████ and asked her to check the basement for any other missing items. ██████ checked the basement and did not find anything missing but did notice some folded laundry lying on the floor. ██████ said the laundry was left on top of the washer and dryer. We exited the exterior basement door and checked the basement window behind the washer and dryer. ██████ then pointed out on the ground just below the basement window a piece of a wooden chair leg support that was used to secure that basement window from within. I then observed where gathered debris on the window frame was disturbed and a scratch where it looks like someone slid their way into the basement window.

I took photographs and dusted for latent prints finding no prints.

██████ then advised that the key she kept in the basement exterior door deadbolt inside was missing.

I gave ██████ the case number and requested she have the door locks changed, as well as secure the unsecure basement window behind the laundry machines.

██████ advised she would be purchasing an alarm system.
