This information is intended to be part of the original report.

On 02-18-2013, I was made aware of an investigation by [REDACTED] of Internal Auditing that involved an employee of the Floyd County Extension Office.

His investigation revealed that an employee had been employed by another employer for two weeks and had not taken leave time from the University, thereby getting paid by the University while employed elsewhere. The dates in question are June 11th through June 15th, 2012, and July 9th through July 13th, 2012.

The amount of money paid to the employee by the University of Georgia for the period of June 11th - 15th is \$833.34. The amount of money paid to the employee by the University of Georgia for the period of July 9th - 13th is \$795.45. The total loss is \$1,628.79.

On 02-26-2013, I appeared before Judge Bob Couey of the Floyd County Magistrate Court. I obtained two misdemeanor Theft by Deception arrest warrants for Brewster and they were left with the clerk of Magistrate Court.

I spoke with Brewster and made her aware of the warrants.

This case is cleared by arrest.

On 022613 at 1415 hours the reporting party [REDACTED] reported that a black Honda Civic, located on the third level of the South Campus Parking Deck, driver's side window was busted out and the stereo was ripped out. I was unable to meet with the reporting party due to that she already left when I arrived on scene.

On 022613 at 1537 hours I met with the victim on the third level of the South Campus Parking Deck in reference to a report of an entering auto. The victim stated that between 0917 hours on 022613 and 1415 hours on 022613 that an unknown individual unlawfully entered his black 2004 Honda Civic [REDACTED] while it was parked on the north side third level of the South Campus Parking Deck. The victim stated that his silver Sanyo CD/Radio player (\$100.00) and a black cell phone car charger (\$15.00) were taken for a total loss value of \$115.00. Forced entry was made on the driver's side window. The driver's side window was busted out. Photographs were taken on scene. I dusted for latent finger prints on scene. A GCIC entry could not be made due to the lack of information at the time of the incident. The victim was given a case reference card.
