**Notes/Narratives****NARRATIVE**

On 03/17/14 at approximately 0847 hours, a University of Georgia student notified a University of Georgia Official who notified the University of Georgia Police Department that a professor known to her asked the student to obtain a regulated dangerous drug by fraudulent means while the student was visiting Mexico. The professor provided the student with \$120 in cash in order to purchase the drug, but no prescription for the regulated dangerous drug.

The subsequent investigation led to obtaining the following arrest warrants.

On 03/19/14, Clarke County Magistrate Court Judge Makin signed a misdemeanor warrant for attempting to obtain regulated drugs by fraudulent means and three misdemeanor warrants for drugs not in original container. All four warrants were turned over to the Athens Clarke County Sheriff's Office for service. The offender's attorney was notified of the arrest warrants after they were signed.
