On June 4, 2013 at approximately 1159 I was dispatched to [REDACTED] in reference to a burglary. When I arrived on scene I met with the victims.

[REDACTED] advised me that on Sunday, June 2, 2013 he was asleep in his bedroom when he heard someone enter the apartment through the front door. He said the suspect exited the apartment approximately 5 minutes later. He said he was not suspicious because he thought his roommate, [REDACTED] had returned to retrieve an item he forgot when he left. [REDACTED] said this occurred around 0600 or 0800. He said when he got out of bed later that morning he noticed his laptop, that had been sitting on the kitchen counter was missing. [REDACTED] said the front door was left unlocked and there was no forced entry into the apartment.

[REDACTED] described his laptop as a white Mac Book. He said he had a Marine Corps, a "Kill Cliff," and a GNC sticker on the top of the computer. He also stated that the rubber backing on the bottom of the computer was falling off. He said he used duct tape stamped with University of Georgia insignia to hold the rubber on the computer. [REDACTED] valued his laptop at \$1300.

While on scene I also spoke with [REDACTED] advised me that he went to Six Flags theme park on Sunday, June 2, 2013. He said when he returned to his apartment he discover his laptop was also missing. He said he left his laptop on the coffee table in the living room. [REDACTED] said the power cord to his computer was plugged in near the television and was also missing.

[REDACTED] described his laptop as a silver Mac Book. He said it had a black case on it with a University of Georgia "G" sticker. [REDACTED] valued his laptop at \$1300.

I provided both victims with a case number.

NARRATIVE

On 06-04-2013 at 2350 I responded to the area of Clayton St. for an altercation between the staff of the Lazy Shopper and a black male who was trying to steal some cigarettes. Dispatch advised that the suspect was a black male in a black shirt with a logo on the front that was walking down Clayton St. passing Flannigan's and Moon Shines.

I saw a male matching the description at the corner of College Ave. and Clayton St. I stopped and got out of the car and told the male to come to me. He said "who me?" and I responded yes. He then broke and ran west bound on the north side of Clayton St. down the sidewalk. I yelled for him to stop as I chased him down the sidewalk. SPO McFaddin was in the passenger seat of the vehicle when I took off after the suspect. SPO McFaddin got the vehicle as I called out the direction of travel. As we crossed Lumpkin St. the male was looking back at me, then in front of Georgia Bar the male cut across Clayton St. towards the old Suntrust lot.

SPO. Mcfaddin pulled up and got out of the car and took over the foot pursuit and I got in the car. SPO Mcfaddin was closing quickly on the suspect as they got to the sidewalk in front of the old Suntrust lot. I saw the suspect slow up the try to evade us by moving sideways as SPO McFaddin got to him. I then saw SPO McFaddin trying to grab the male. I saw the male trying to use a small tree to keep away from SPO McFaddin. SPO McFaddin tried to take the male down with a leg sweep. I saw the male with his hands up around SPO McFaddin's head. SPO McFaddin managed to push the male down to his knees. As I pulled up, the male was on his knees facing SPO McFaddin grabbing at SPO McFaddin's legs. I saw SPO McFaddin punch the male about 4 times in the body as I was exiting the vehicle. As I got to them the male yelled "ok ok" and something about you got me. The male was put

on his belly and handcuffed.

I stood the male up and took him over to my patrol car where I started searching him. I found a small amount of Marijuana rolled in a cigar wrapper in his right front pocket. As I was searching the male he told me that he had defecated in his pants. I put on gloves to finish searching him. At that point he turned around on me so I had to forcibly turn him back to the car and push him against the car. We identified the male as Mr. Tate.

We transported Mr. Tate back to the Lazy shopper where I met with Joshua Rabine the clerk. He said that Mr. Tate came in and asked for a pack of Newport Cigarettes. Mr. Rabine said that when he got the regular Newport's Mr. Tate said he wanted the "longs". Mr. Rabine said he switched the cigarettes out and told Mr. Tate that was \$5.60. Mr. Tate then picked up the pack of cigarettes and shrugged his shoulders and walked out of the store with out paying. I asked if they got into a physical altercation with Mr. Tate and he said no. He said that he followed him and got the cigarettes back but they were already opened. He said that he saw us start chasing the male. I reviewed the video from the store and it matched Mr. Rabine's story. Mr. Rabine said that he wanted Mr. Tate warned of criminal trespass from Lazy Shopper for two years. SPO McFaddin relayed the message to Mr. Tate and he was warned of criminal trespass from the Lazy Shopper.

SPO McFaddin transported Mr. Tate to the Clarke County Jail. Due to the speed that this incident developed I was not able to turn on my audio recorder.

He said he was playing soccer today at Bishop park and upon arriving home he received an email from Sears in regards to his account. He said he thought he had the cards inside his wallet but was not sure if he had them today or if they were taken while on vacation. The Bank of America credit card was charged in the amount of \$2330.94 at the Apple Store which was not declined at the time of purchase. The Chase card was charged in the amount of \$2330.94 as well which was declined. The Sears/Citi Bank card was charged in the amount of 2407.04. There were also attempts made to charge \$711.00 to the cards but these were declined.

[REDACTED] has already spoken with the Card companies to cancel these cards.
